

Vonzelle Moore do grant, bargain, sell and convey unto the said
Ada M. Bozeman, a widow

the following described real estate situated in Shelby County, Ala., to-wit: Commencing
at the Northeast corner of Southwest Quarter of Southeast Quarter of
Section 14, Township 21 South, Range 1 West, and run South 3°30' East
along the East boundary of said Southwest Quarter of Southeast
Quarter, 160 feet for point of beginning of the lot herein conveyed;
continue thence in the same direction 160 feet; run thence South
86°15' West, 820.2 feet to the East boundary of the right of way of
the Columbiana-Chelsea Road; run thence North 31°10' West along the
East boundary of said right of way, 75.2 feet; continue thence
along said right of way, North 28°15' West, 100.9 feet; run thence
