RELEASE FROM LIEN

KNOW ALL MEN BY THESE PRESENTS:

For and in consideration of the sum of One Hundred Ninety and 45/100 Dollars (\$190.45) in hand paid to me, in my official capacity as Acting Director of Industrial Relations for the State of Alabama, as successor in office to Joe L. Coleman, formerly Director of Industrial Relations for the State of Alabama, and with full authority in the premises, I, Murray A. Battles, in my official capacity aforesaid, for the use of the Unemployment Compensation Trust Fund, do hereby forever quitclaim and release the hereinafter described real property located in Shelby County, Alabama, from the operation of that certain lien heretofore filed for record in the Probate Court of Shelby County, Alabama, in Judgment Record F, at page 123, and styled "Joe L. Coleman, as Director of the Department of Industrial Relations for the State of Alabama, for the use of the Unemployment Compensation Trust Fund vs. J. S. Massey, individually and doing business as J. S. Massey, Contractor:"

NW $\frac{1}{4}$ of NE $\frac{1}{4}$

NE $\frac{1}{4}$ of NW $\frac{1}{4}$ South of the Old Saginaw Railroad bed.

SW $\frac{1}{4}$ of NW $\frac{1}{4}$, except the following: 3.1 acre more or less and being more particularly described as follows: Beginning at the NE corner of said SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 8, run thence West along the north line of said forty, a distance of 525 feet to the point of beginning of the lot herein excepted; and from said point of beginning of the lot herein excepted; and from said point of beginning, run South 450 feet, thence West 300 feet, thence North 450 feet to the North line of said forty, thence East along said north line to point of beginning, this being the land upon which the Complainant lives.

The NW $\frac{1}{4}$ of the SW $\frac{1}{4}$, except as follows:

(1) 2 acres along the South side thereof
 (2) Except what is known as the James Carden lot described as follows: A part of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Sec. 8, T 21 R 2 W described as follows: Begin at the SW corner of said forty acres and run East 435 feet, thence North and parallel with West line of said forty acres 766 feet to the point of beginning of the tract herein excepted thence continue North 250 feet, thence West 150 feet, thence South 300 feet to a ditch, thence northeast along said ditch 158 feet to the point of beginning, and containing one acre more or less.

(3) Except also the Charlie Seales lot described as follows: Begin at the SW corner of said 40, thence North along the West line of said forty, 66 Ft. for point of beginning, from said point of beginning run East 320 feet, thence North to drainage branch, thence West along drainage branch to the West line of said forty, thence South along the West line of said forty to point of beginning, containing 4 acres more or less.

All that part of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$, less 10 acres off the North side thereof, and except also the Old Saginaw Railroad bed. Mineral rights excepted.

That part of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$, described as follows: Commence at the West line of said forty, 330 feet South of the NW corner, thence South 640 feet more or less to the old Saginaw logging railroad bed, thence Easterly along said logging railroad bed to the East line of said forty which is 818 feet South of the NE corner of said forty, thence North 488 feet to a point 330 feet South of the NE corner of said forty, thence West and parallel with the North line of said forty 1320 feet more or less to point of beginning. Mineral rights excepted.

- All of said land is situated in Section 8, Township 21, Range 2 West, Shelby County, Alabama.

It is the intent of this instrument to forever release the above-described real property from the operation of the above-described lien.

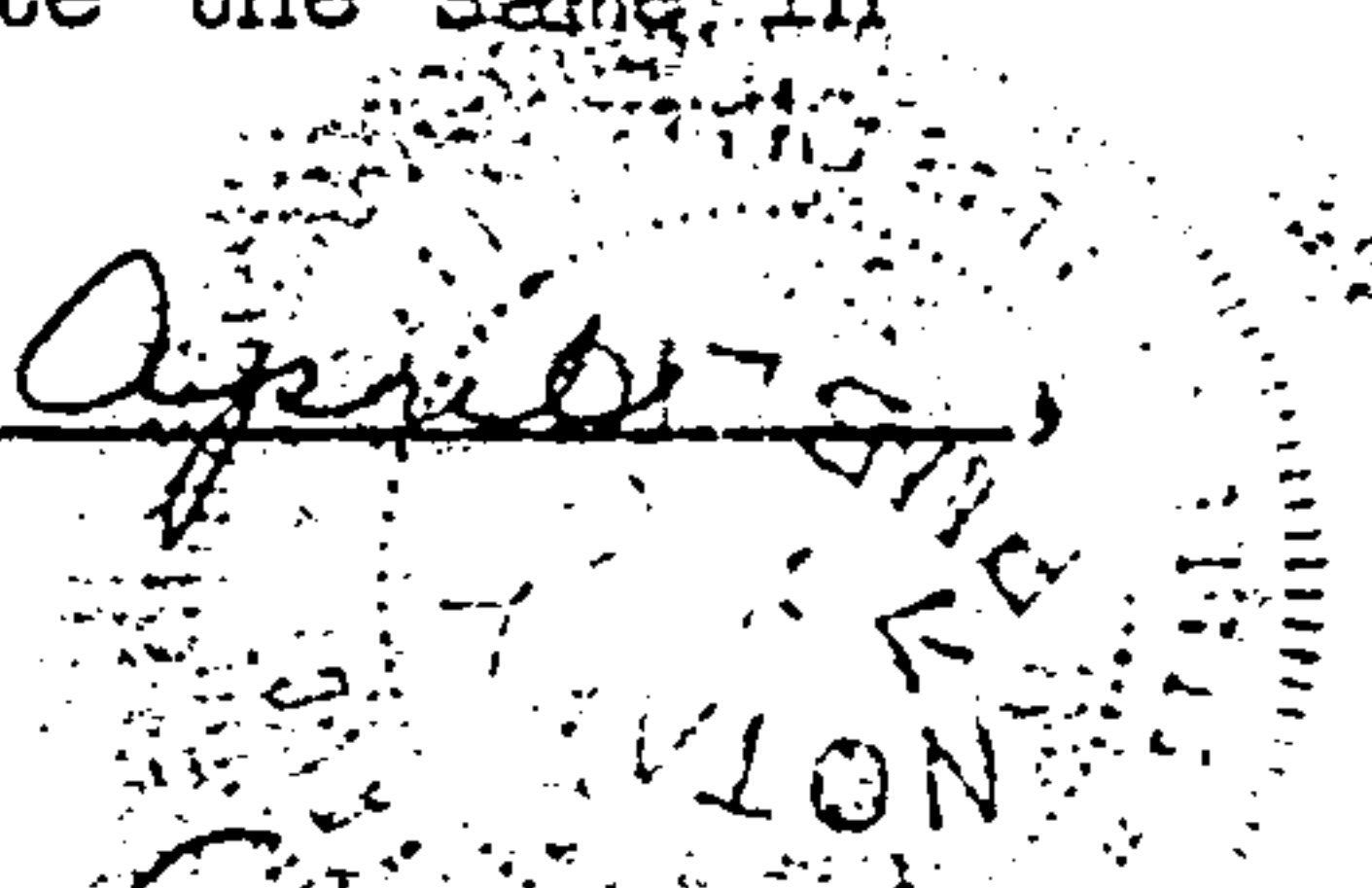
