Pilgreen and wife went into possession of said above described land and occupied the dwelling situated on said land as a dwelling. That J. T. Pilgreen was living on such property at the time of his death and his widow and children sold the property to T. S. Collins on the 18th of February, 1927. That upon the execution and delivery of such deed said T. S. Collins, who was one and the same person as Thomas S. Collins took possession of such land and allowed his father in law to live upon such land. That in August, 1936, said Thomas S. Collins and wife sold such property to J. M. Pilgreen who went into possession of the land upon the execution and delivery of such deed and lived upon such land and in the house situated on such land I learned last winter that until/he moved.
