

JEFFERSON COUNTY

Before me the undersigned authority in and for said county, in said state, this day personally appeared J. H. Barker, who being first duly sworn, deposes and says:

My name is J. H. Barker. I am the grantee in that certain deed dated July 14th, 1928 as recorded in Deed Book 83 page 202 in the Probate Office of Shelby County, Alabama.

During the latter part of the year 1928 I had the land described in said deed surveyed and a map prepared, certified to and adopted to be recorded in the Probate Office of Shelby County, Alabama. It is my best judgment that said map was recorded in the Probate Office of Shelby County, Alabama, however, said map does not appear to be of record in said Probate Office at this time.

On To-wit: the 25th day of February, 1930, I sold to Bankers Mortgage Building and Loan Association of Alabama Lots 9 and 10 together with other lots all according to J. H. Barker's Survey of a part of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 1 Township 20 Range 3 West and the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 6 Township 20 Range 2 West. In view of the fact that the said J. H. Barker's Survey of said land does not now appear to be recorded in the Probate Office of Shelby County, Alabama, I have this day executed to Mrs. H. B. Williams a quit claim deed in which said quit claim deed I have described as a whole the tracts of land known as lots 9 and 10 according to said J. H. Barker's Survey. The land described in said J. H. Barker's Survey as lots 9 and 10 is described by metes and bounds as follows: to-wit:

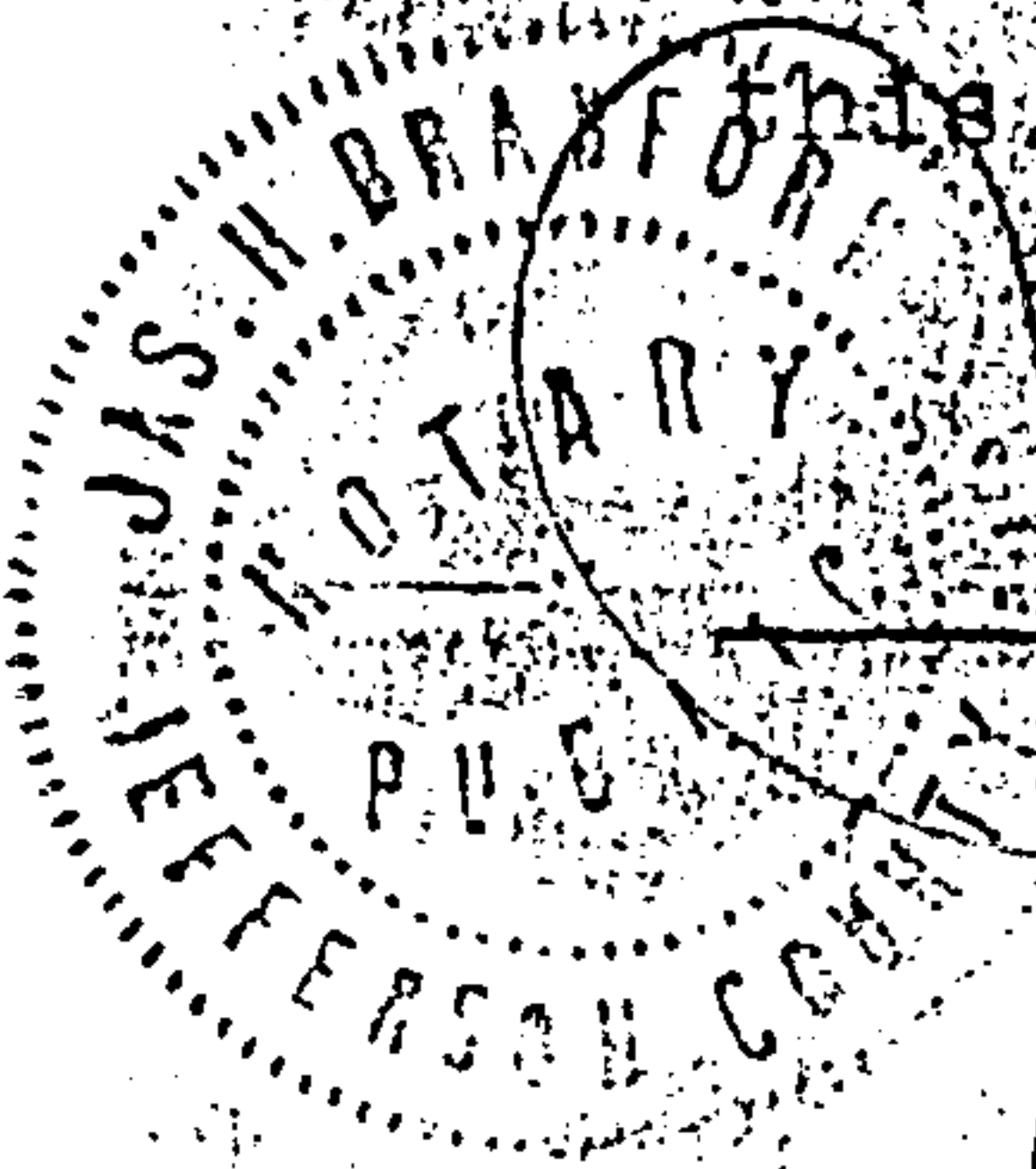
A part of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 6, Tp 20 R 2 West more specifically described as follows: Commence at the Southeast corner of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$ run thence West along the South line of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$ 598.18 feet; run thence 28 degrees 31 minutes to the right a distance of 798.36 feet to the East line of the Montgomery Highway as located in the year 1928; run thence in a Northeasterly direction along the East line of said Highway 262.21 feet to a point; from said point continue in the same general direction along the East line of said highway for a distance of 274.54 feet; run thence in a Southeasterly direction to a point on the East line of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$ which said point is 320.73 feet North of the Southeast corner of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$; run thence South along the East line of said NW $\frac{1}{4}$ of SW $\frac{1}{4}$ a distance of 320.73 feet to point of beginning.

The original map which was certified to and adopted of said lands and known as the J. H. Barker's Survey of said land was delivered to Bankers Mortgage Building and Loan Association of Birmingham, Alabama, and that thereafter said building and loan association was liquidated and that affiant cannot locate said map of said survey at this time.
