WILL OF GEORGE GILMER TAIT

I give J. Marsh Tait my old lean back chair, once Charles Tait, the leg man, now at Rosa Tait McDaniel.

I give my book case to Lillie Hope Tait, now at her mother home in Canton.

I give my chest of old drawers to Charlotte Ervin Tait, now at Rosa Tait McDaniels in Camden.

I give my old sofa to my brother, S. G. Tait, sofa now at Rosa Tait McDaniels in Camden.

I give my 3 barrel gun to S. G. Tait for his life to go to Robert Tait at death of S. G. Tait.

I give and bequeath my old home place in Canton Ben, near Camden, Alabama, Two Hundred and fifty acres more or less, to my brother Sidney Goode Tait, and all of my other property, real estate and personal, I give to my brother Sidney Goode Tait and to the children of my deceased brother Frank S. Tait and of his wife Mrs. Maggie Marsh Tait, half to Sidney Goode Tait and half to the children of my deceased brother Frank S. Tait, to be divided as best can be done. I want a monumemt costing not less than \$100.00 placed over my grave. I want a monument costing not less than One Hundred dollars each to be placed over the grave of my brother Robert Tait, and one placed over the grave of my sister Anna Ervin Tait, both buried near the place of our birth, near Rock West. Should my sister Rosa Tait McDaniel survive me, she shall have the use of any and all of my personal property for her lifetime if she so desire.

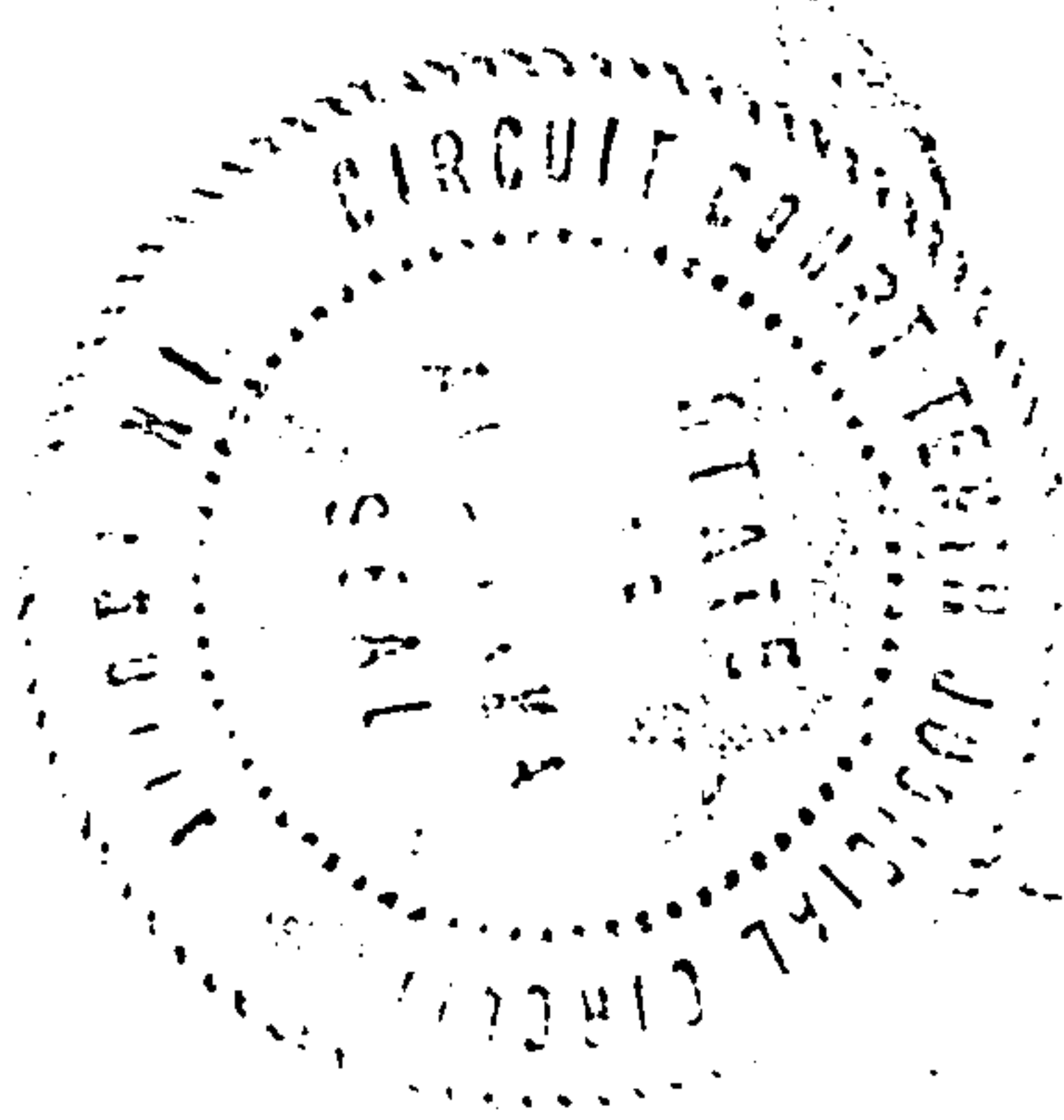
