Shelby, State of Alabama: Lot #19 Block #6

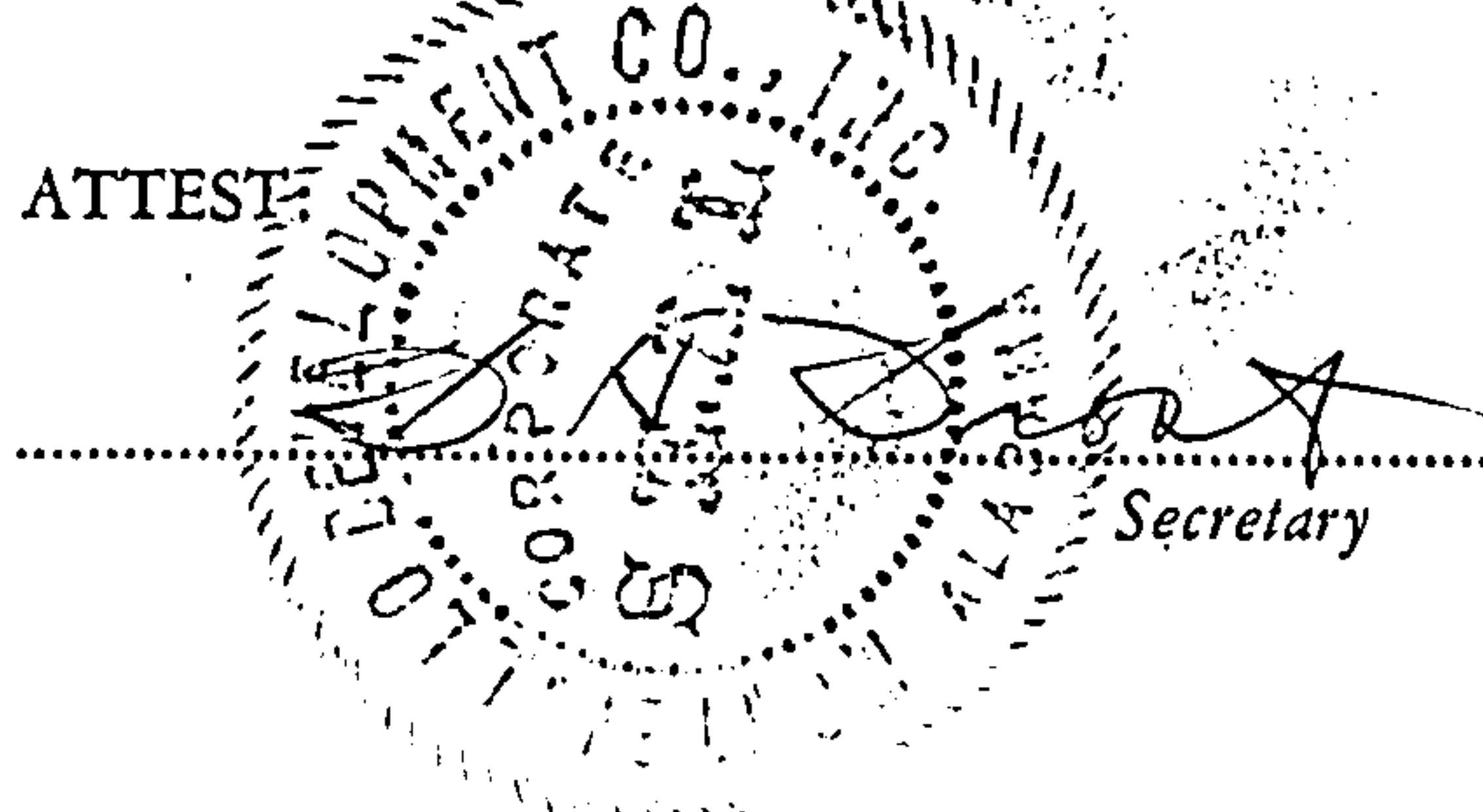
all according to Arden Subdivision to the Town of Montevallo, Alabama, and subject to the restrictions

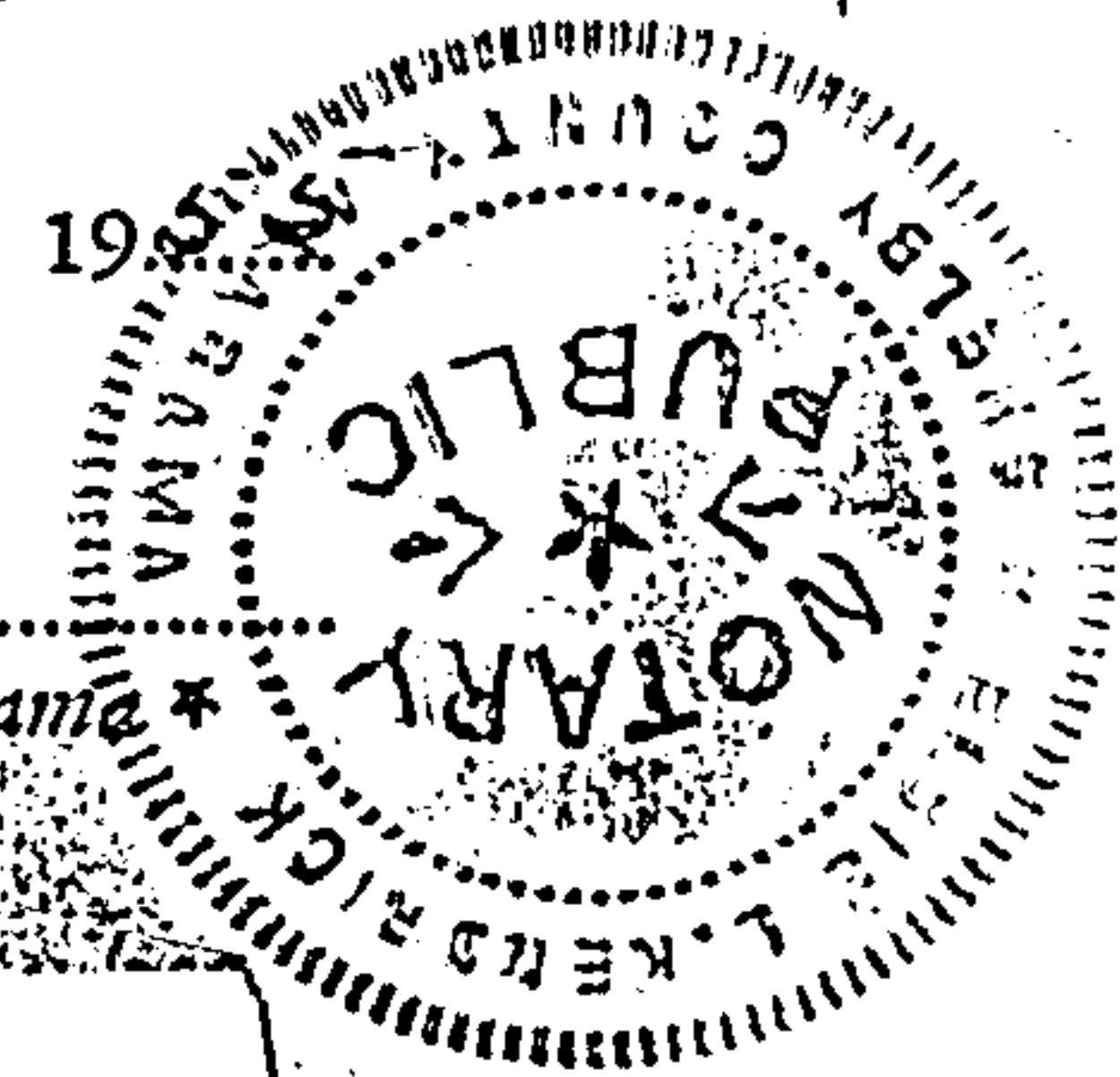
