Personally appeared before me, the undersigned authority,
Mrs. Ella Dunnam who, being by me first duly sworn, deposes and
says as follows:

My name is Ella Dunnam and I am a resident of Helena,
Shelby County, Alabama, and have been such resident
for many years; I was a neighbor of J. T. and Mary
Boothe, who, during their lifetime, owned the following
described real estate:

All of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 33, Township 20, Range
3 West, that lies west of Beaver Dam Creek.
All of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 4, Township 21, Range
3 West, that lies Northwest of Beaver Dam Creek.
Also a part of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. 33, Tp. 20, Range
3 West and a part of the N $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 4, Township
21, Range 3 West, more particularly described as follows:
Begin at the point of intersection of Beaver Dam Creek
with the East line of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 4, Tp. 21,
Range 3 West; thence run southwest along said creek to
the south line of said NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 4,
thence west along said south line 1328.2 feet, more or
less to the east line of the Reeves property; thence
north 26 degrees 26 minutes east along a fence 2304 feet
to Dry Creek; thence in a northerly direction along
Dry Creek to the north line of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of said
