

WHEREAS, RFC desires to revoke, as of this date, the powers given to said FRED H. FOY under the above described instruments, or otherwise, without affecting or impairing in any way any act heretofore lawfully done by him thereunder;

NOW, THEREFORE, RFC does hereby revoke, terminate, and make null and void as of this date, all the powers and authorities given under and by said powers of attorney, and by any other power of attorney, to said FRED H. FOY; provided that this revocation shall not prejudice or affect anything lawfully done or caused to be done by said FRED H. FOY in the exercise of any of the powers contained in said powers of attorney between the dates thereof and the date of this revocation.
