do grant, bargain, sell and convey unto the said J. E. Walker

the following described real estate situated in Shelby County, Ala., to-wit:

Begin at the southeast corner of Lot 25 in Block 2 according to Nickerson-Scott Survey, being a subdivision of a part of E 1/2 of SE 1/4 of Section 35 and part of the NW 1/4 of SW 1/4 of Section 36, Township 20, Range 3 West, which map is recorded in the Probate Office of Shelby County, Alabama, in Map Book 3. From said beginning point run in a northwesterly direction along the south line of Lot 25, 420 feet to the southwest corner of said Lot 25; thence in a southwesterly direction along the west line of Lots 24, 23 and 22, 150 feet to the northwest corner of Lot 21 in said Block 2; thence run in a southeasterly direction and parallel to the south line of said Lot 25, a distance of 223 feet; thence in a southwesterly direction and parallel with the east line of said Lot 21, a distance of 50 feet; thence run in a southeasterly direction and parallel with the south line of said Lot 25 to the east line of said Section 35; thence along same north to a point which will be intersected by an extension of the south line of said Lot 25; thence in a northwesterly direction along said extension to the southeast corner of said Lot 25 to the point of beginning.


