Witnesseth, That the party of the first, in consideration of the sum of ONE HUNDRED FIFTY
AND NO/100-----DOLLARS
(\$150.00---) paid by the party of the second part, the receipt whereof is hereby acknowledged,

does hereby grant, bargain, sell and convey unto the said party of the second part the following
described real estate, to-wit:

Begin at a point in the West line of the $3\frac{1}{2}$ of the $3\frac{1}{2}$
of Section 34, Township 17, Range 1 East, in Shelby County,
Alabama, where the old Dunavant-Ashville or Valley Road
intersects the said west line of said 40 and said point
being also in the north right-of-way line of said road;
thence north along the west line of said 40 a distance of
292.5 feet to a point; thence west and parallel to the
north and south lines of said 40 a distance of 150 feet
to a point; thence south and parallel to the east and west
lines of said 40 to a point in the north right of way line
of said road; thence east and along the north right-of-way
line of said road to the point of beginning, containing one
(1) acre more or less, lying and being in Shelby County,
Alabama, as described above.
