the following described real estate situated in Shelby County, Alabama, to-wit: That
part of the Southwest Quarter of the Northwest Quarter of Section 31,
Township 19,Range 2 West, described as follows:Commencing at the South-
west corner of said Southwest Quarter of the Northwest Quarter of
said Section 31, and run thence in an Easterly direction along the South
line of said Southwest Quarter of the Northwest Quarter of said Section
31, for a distance of 609.4 feet to a point; thence turn an angle to the
left of 44 degrees and run in a Northeasterly direction for a distance
of 130.5 feet to the point of beginning of the lot herein described and
conveyed :Thence turn an angle to the left of 85 degrees and 39 minutes
and run in a Northwesterly direction for a distance of 306 feet to an
iron stob;thence run in a Northeasterly direction for a distance of 90
feet, more or less, to the Westernmost corner of that certain tract of

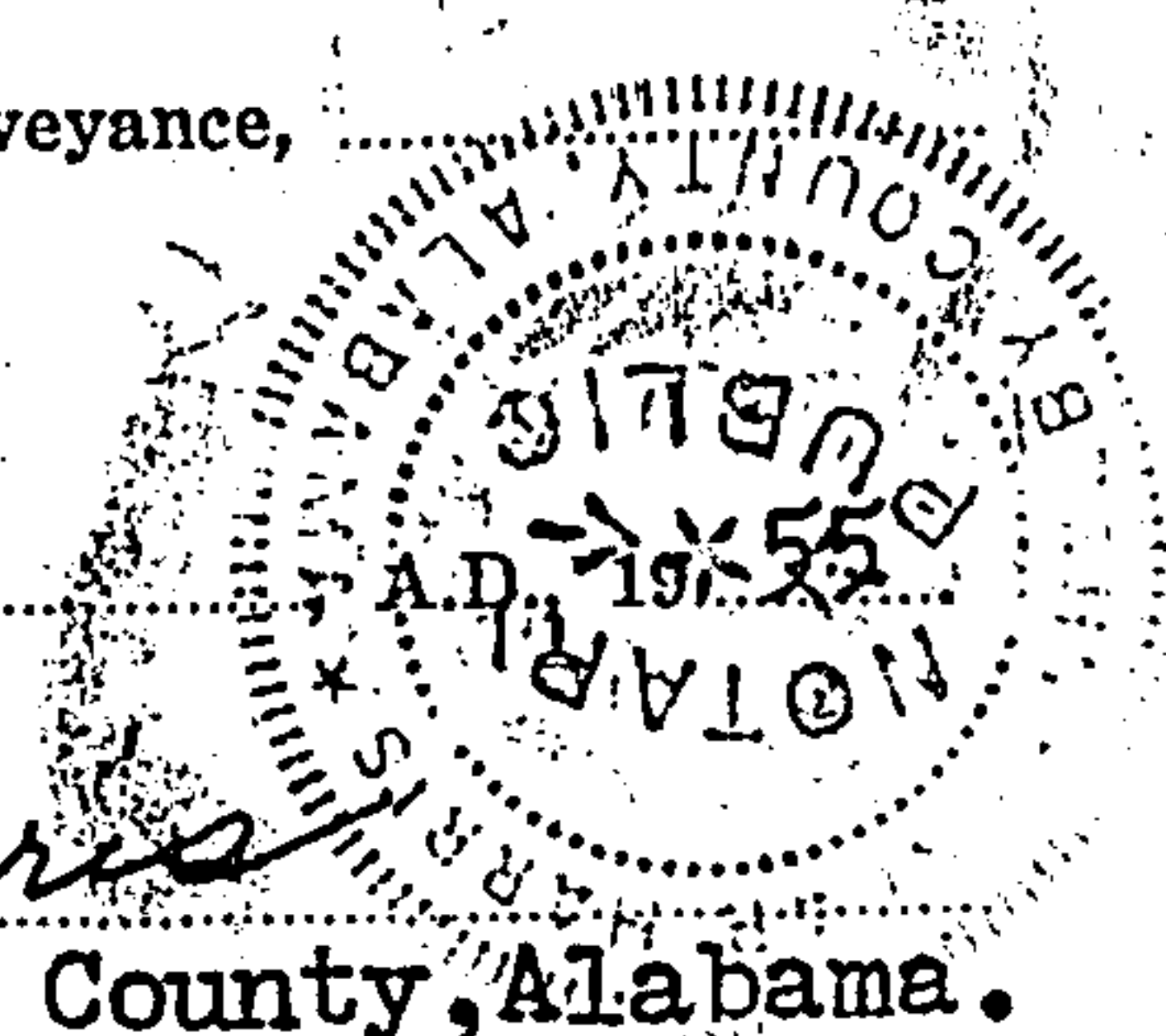
