


KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE DOLLAR to the undersigned grantors O. K. Lamb and S. Elbert W. Boozer, as Trustees for the Homes for Conference Claimants of the Anniston District of the North Alabama Conference of The Methodist Church, in hand paid by Luther Fowler, P. O. Luck, W. L. Christian, A. A. Lauderdale, J. R. McMillen, J. I. Harrison, and F. E. Leonard, as Trustees of The Columbiana Methodist Church, the receipt whereof is acknowledged, we the said O. K. Lamb and S. Elbert W. Boozer, as Trustees for the Homes for Conference Claimants of the Anniston District of the North Alabama Conference of The Methodist Church, do grant, bargain, sell and convey unto the said Luther Fowler, P. O. Luck, W. L. Christian, A. A. Lauderdale, J. R. McMillen, J. I. Harrison and F. E. Leonard, as Trustees of The Columbiana Methodist Church, the following described real estate, To-wit:


A lot situated in the Town of Columbiana, Shelby County, Alabama, more particularly described as follows:

Begin at a point where the West line of Section 25, Township 21, Range 1 West, intersects the South line of Mildred Street and go thence along said South line and in an Easterly direction 820 feet to the Northwest corner of the property now owned by Mrs. Knox Wooley; thence South 4° East along the West line of the property owned by Mrs. Knox Wooley 105 feet to the point of beginning of the lot hereby conveyed; thence continue South 4° East 105 feet; thence South 83° West 100 feet; thence North 4° West 105 feet; thence North 83° East 100 feet to the point of beginning; said property being a Southerly extension of equal width of the Parsonage lot of The Columbiana Methodist Church and for a distance of 105 feet.

TO HAVE AND TO HOLD, To the said Luther Fowler, P. O. Luck, W. L. Christian, A. A. Lauderdale, J. R. McMillen, J. I. Harrison, and F. E. Leonard, as Trustee of The Columbiana Methodist Church, their successors and assigns, forever, in trust, that such premises shall be held, kept, and maintained as a place of residence for the use and occupancy of the ministers of The Methodist Church who may from time to time be entitled to occupy the same by appointment; subject to the Discipline and usage of said church, as from time to time authorized and declared by the General Conference and by the Annual Conference within whose bounds the said premises are situated. This provision is solely for the benefit of the grantee, and the grantor reserves no right or interest in said premises.
