Beginning at a pipe on the east boundary line of Section 6, Township 24, North, Range 13 East and on the north margin of an old road and 3144.4 feet north of the southeast corner of said Section 6; thence south, 03 degrees 03 minutes west, 123.0 feet with the east line of said Section 6 to a pipe; thence south, 85 degrees 38 minutes west, 1429.5 feet to a pipe by a line fence; thence northly with said line fence 101.0 feet to the north margin of said old road; thence north, 79 degrees 20 minutes east along the north margin of said old road 200.0 feet; thence north, 85 degrees 38 minutes east along the north margin of said old road 1220 feet, more or less, to the point of beginning; containing 3.99 acres and lying in the S½ of the NE½ of Section 6, Township 24 North, Range 13 East, Shelby County, Alabama.

TO HAVE AND TO HOLD to the said United Cement Company, Inc., a corporation, its successors and assigns forever.

It is understood and agreed that this release shall not in any way impair or affect the right of the said mortgagee to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid on said mortgage.
