Before me, the undersigned authority, in and for said County and State, personally appeared Annie C. Williamson who being known to me and being duly sworn according to law, deposes and says as follows:

That she has been acquainted with the owiership, use and possession of the following described property for the last past fifty years:

Commence at the Northeast corner of the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 26, Township 19, Range 1, West and run along the East boundary of said forty South 3° East 171.4 feet, more or less, to the South right of way line of the Florida Short Route Highway #280, thence run along the South right of way line of said highway #280 South 66° 11' West 548 feet to the point of beginning of the lot herein described; thence turning 72° 10' to the left and run South 5° 59' East 155 feet; thence turning 106° 23' to the left and run North 67° 38' East 97.57 feet; thence turning 91° 27' to the left and run North 23° 49' West 150 feet to the South right of way line of said highway, said point being 50 feet from the point of beginning; thence run South 66° 11' West along South right of way line of said highway 50 feet to point of beginning, MINERAL & MINING RIGHTS EXCEPTED.

Further deposing, affiant says that the above described property was included in a tract of land purchased by affiant's husband, S. P. Williamson in 1902, a record of such conveyance being recorded in the Probate Office of Shelby County, Alabama in Deed Book 109, page 186. Affiant further says that upon the execution and delivery of this said deed to her husband, S. P. Williamson, the said S. P. Williamson immediately went into possession of the said land and resided on a portion of the land and exercised other possession of said land, assessing the same for taxes and paying taxes on the same continuously from the date of purchase up until the same was sold by the husband of affiant to H. P. Williamson in 1929, a record of such conveyance being recorded in the Probate Office of Shelby County, Alabama in Deed Book 109, page 195.

A.C.W. Affiant further says that upon the execution and delivery of such deed to H. P. Williamson, a ^{SON} brother of affiant's husband, said H. P. Williamson went into the actual possession of the tract of land conveyed which included the above described property and continued to farm the same and assess the same for taxes and pay taxes on the same each and every year until the same was sold by said H. P. Williamson to affiant, Mrs. Annie C. Williamson in 1938 which said conveyance is recorded in the Probate Office of Shelby County, Alabama in Deed

Book 109, page 199.

Affiant further says that upon the execution and delivery of this deed that she went into the actual possession of such land and cultivated small patches and a garden on such property each and every year thereafter until the same was sold in 1942 to affiant's son, Boyd W. Williamson. Affiant further says that upon the execution and delivery of such deed which is recorded in the Probate Office of Shelby County, Alabama in Deed Book 115, page 55, said Boyd W. Williamson went into possession of said property and has remained in possession of the same up to and including this date.

Affiant further says that portions of such land have been under fence from the first time she has known the same and portions of the same have been cultivated or in use as a pasture each and every year since she has known such property.

Affiant further says that she has never heard the title of Boyd W. Williamson and his predecessors in title as stated herein, questioned in any way.

Affiant further says that Boyd W. Williamson is one and the same person as B. W. Williamson and affiant further knows of her own knowledge that S. D. Williamson and wife, Hazel Williamson who own adjacent property to the property of Boyd W. Williamson own no part of the property described above and further knows that they have never claimed any interest of any kind in such property.


