This cause coming on to be heard, is submitted for final decree upon the pleadings and proof as noted by the Register; and upon consideration thereof, the Court is of the opinion that the Complainants are entitled to the relief prayed for in their bill of complaint.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED By the Court;

(1) That the Complainants, Clyde Carden and Fannie Mae Carden are the owners of the real estate described in the original bill of complaint in this cause and which real estate is situated in the County of Shelby, State of Alabama, and more particularly described as follows:

The NE $\frac{1}{4}$ of NW $\frac{1}{4}$ and 27 acres on the west side of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 20 Township 22, Range 2 West described as beginning at the NW corner of the NW $\frac{1}{4}$ of NE $\frac{1}{4}$; thence South 2 deg 45' East 1335 feet, thence North 88 deg. 10' East 899.3 ft., thence North 9 deg. 50' West 58.8 feet, thence North 2 deg. 45' West 1261.2 feet, thence South 88 deg. 45' West 901.3' to the point of beginning, in Shelby County.

(2) That Tom Bellamy and wife, Lula Bellamy, the respondents in this cause have no right, title, or interest in, or encumbrance upon such lands above described, or any part thereof.

(3) That the Register, within thirty days from this date, file a certified transcript of this decree for record in the Probate Court of Shelby County, Alabama, the County in which said land lies; and that the Probate Judge record and index said decree as required by code 1940, Title 7, Section 1113.

(4) That the Complainants pay the cost of this suit to be taxed by the Register for which let execution issue.

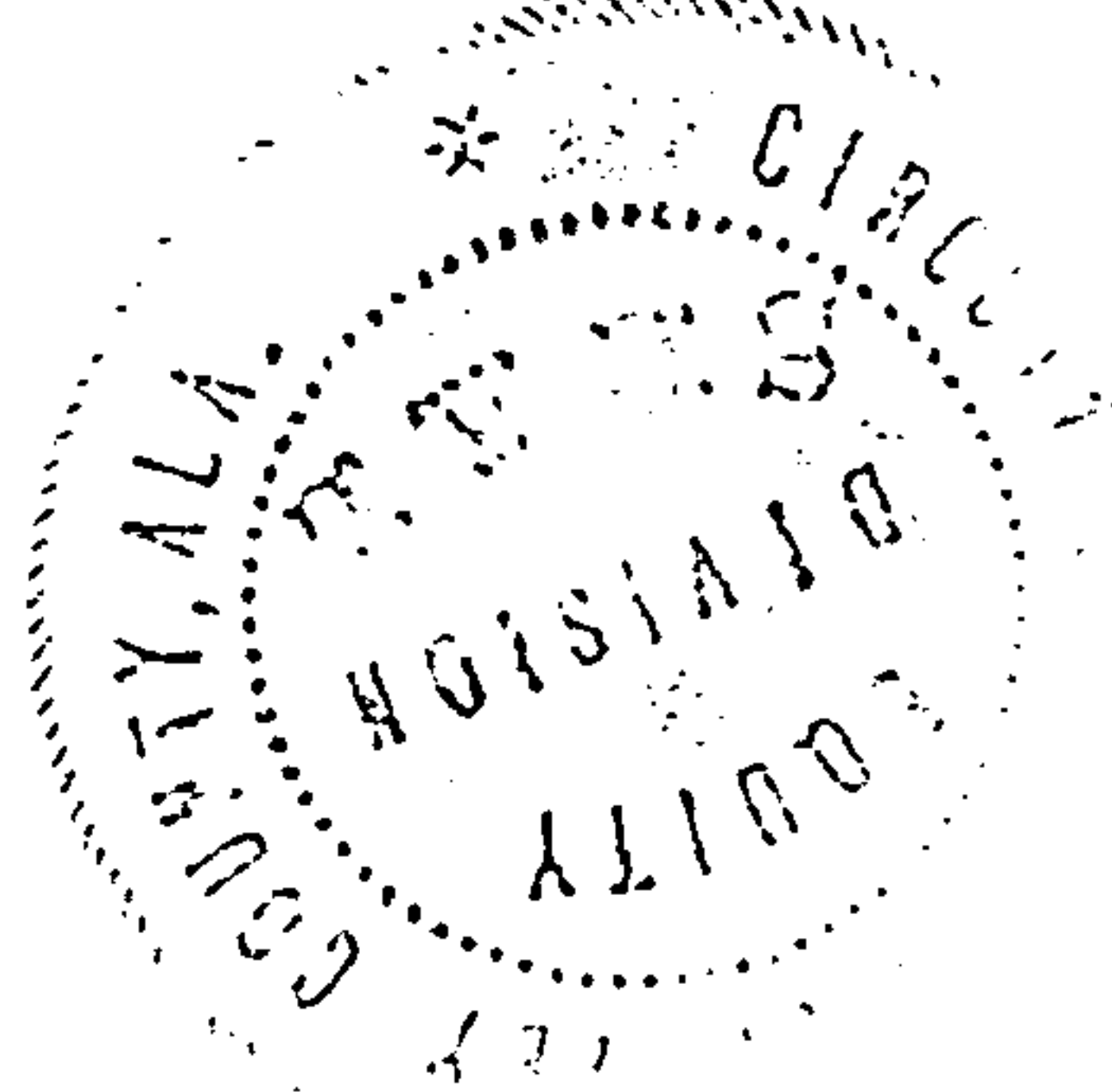
