Lot 8, Block 6



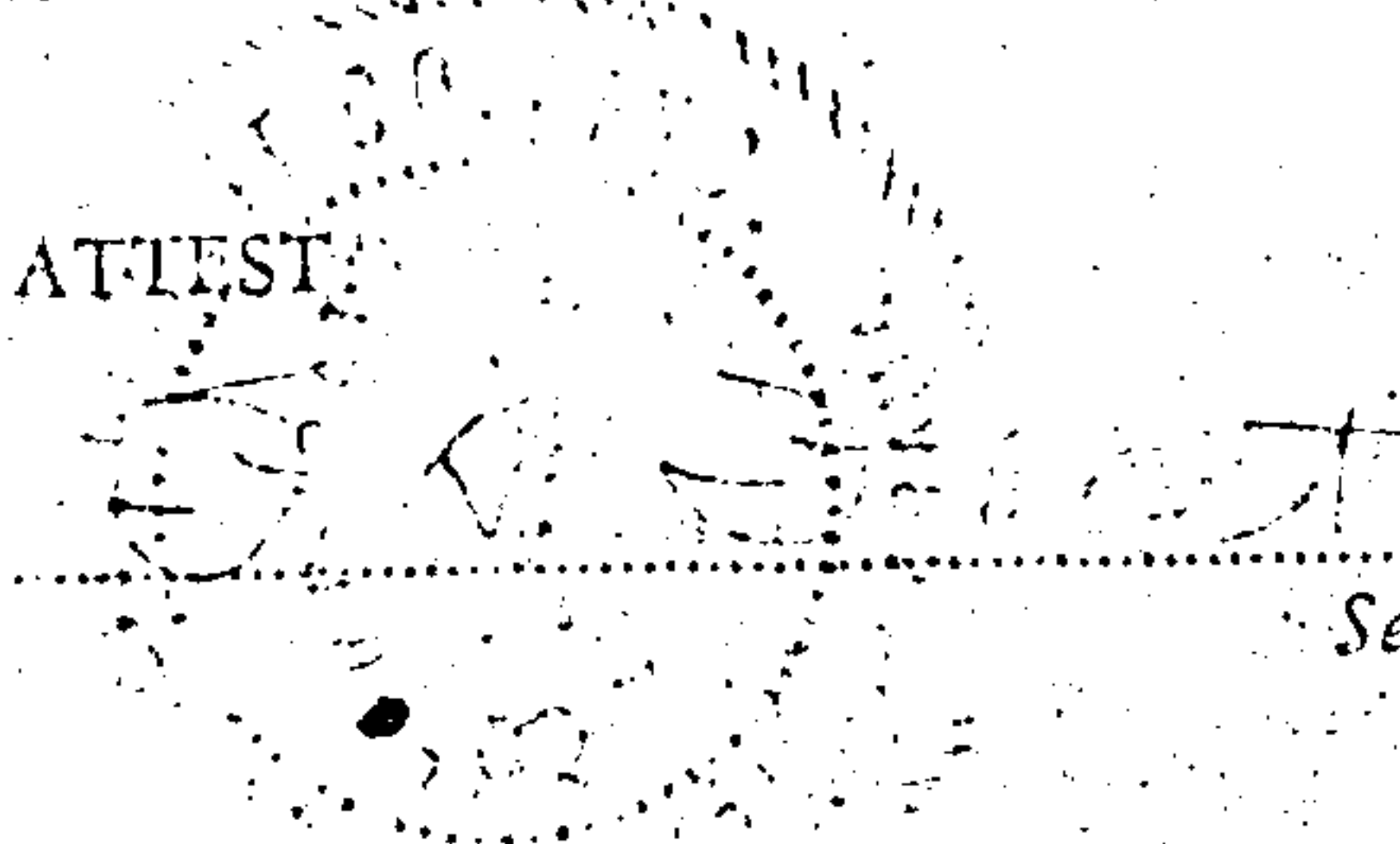

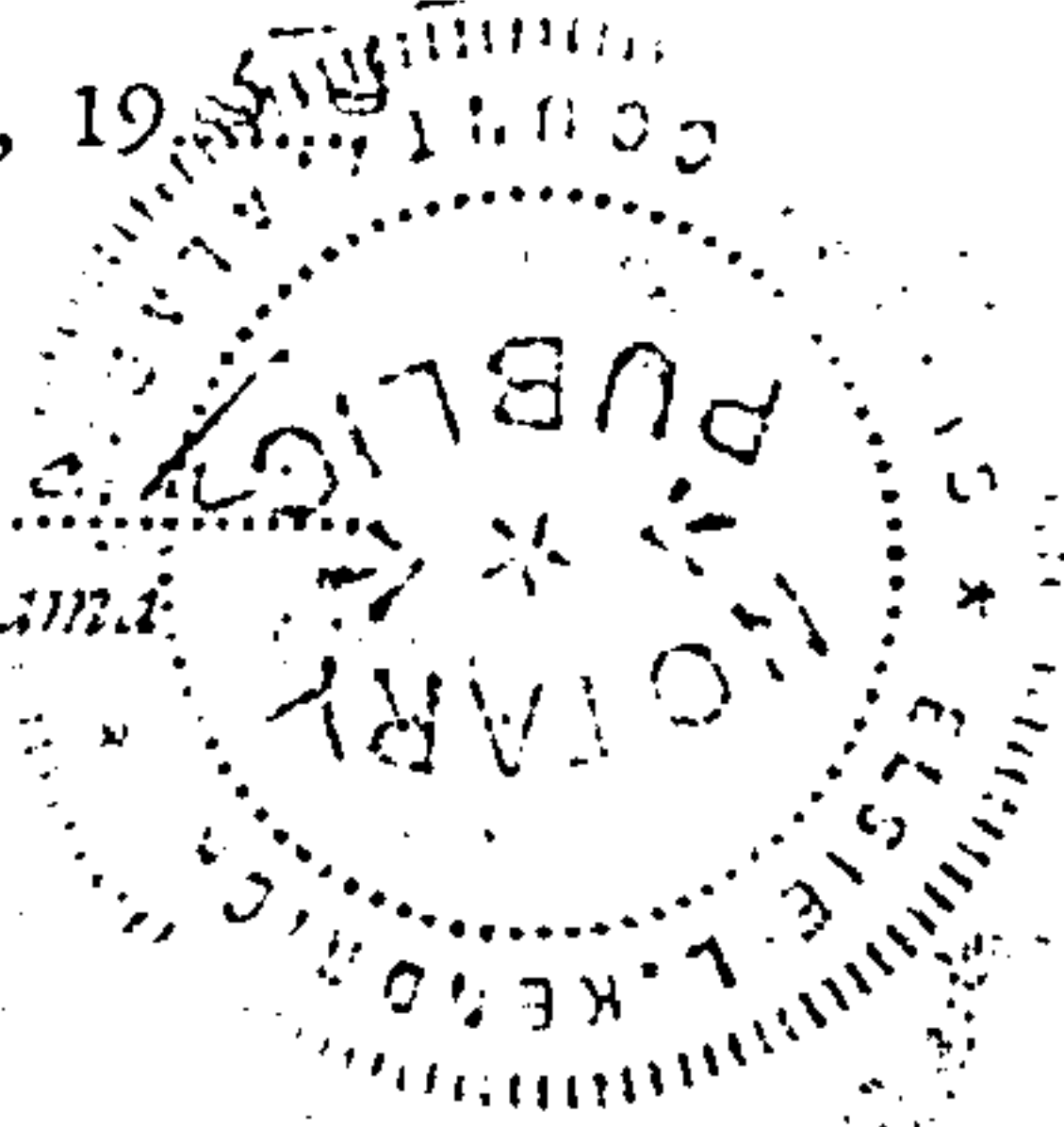
