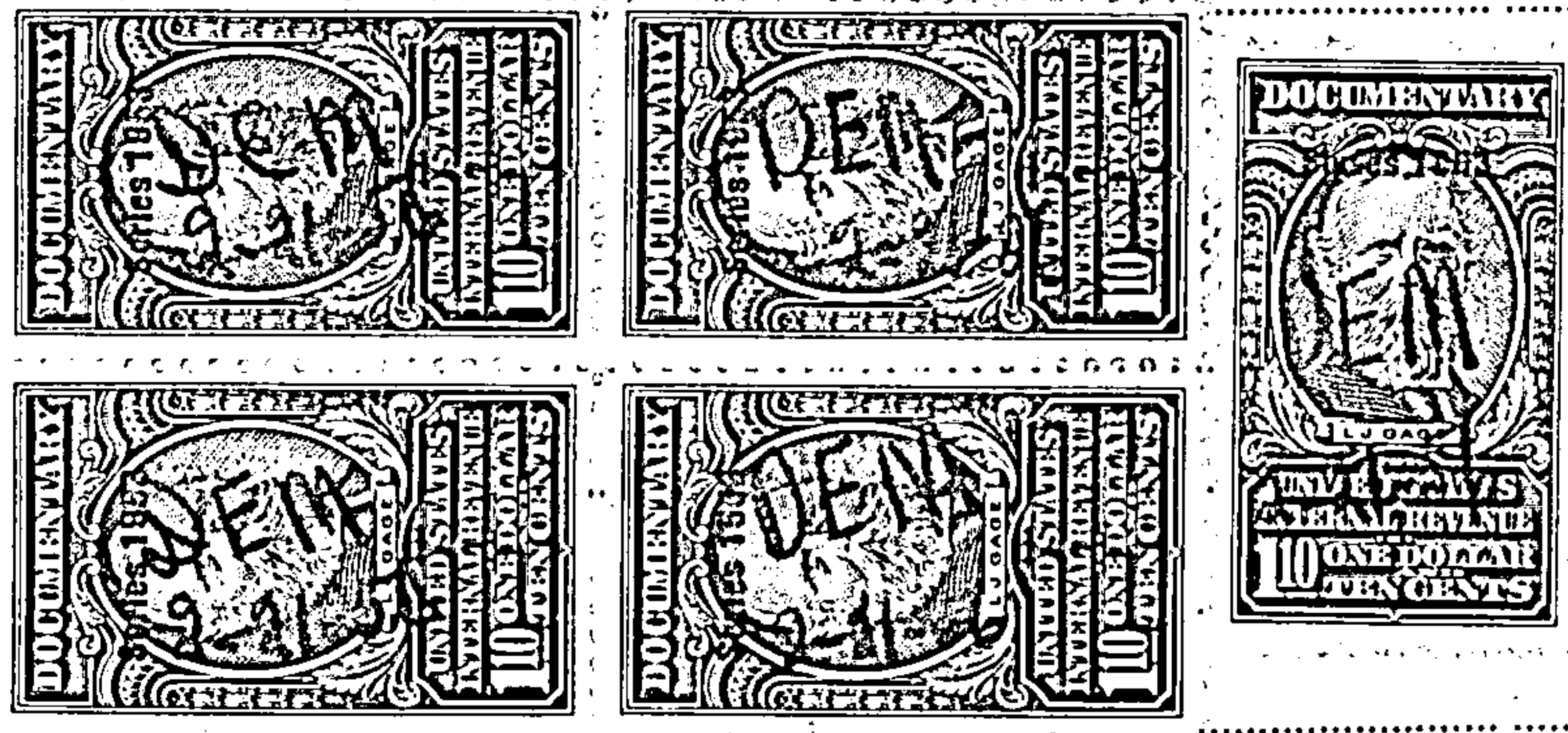
Know all men by these presents, That in consideration of Five Thousand
