other counter-poise conductors under, a strip of land Fifty (50)
 feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over and across the lands of which it is hereinafter described as being a part, said survey to determine the boundaries of said strip, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut and keep clear all trees and undergrowth and other obstruction on said strip and danger trees adjacent thereto which now or may hereafter injure or endanger any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelley
 County, Alabama, described as follows:

SE $\frac{1}{4}$ of section 36, T19S, R3W

Said strip is approximately described as follows: Commence at the S.E. Corner of section
36, T19S, R3W. and run west along the south boundary line of
said section 36, a distance of 2336 feet to a point on the south
boundary line of grantors land in SW $\frac{1}{4}$ of SE $\frac{1}{4}$, section 36, T19S, R3W.
said point being the point of beginning of right of way herein described,
from said point of beginning 25 feet on each side of the following
described center line and the continuations thereof, turn an angle of
130° 25' to the right from the section line and run N 42° 20' E a
distance of 2955.6 feet to a point. Thence from said point turn an
angle of 07° 46' to the right and run N 30° 06' E a distance of
431.9 feet to a point on the east boundary line of grantors
land in NE $\frac{1}{4}$ of SE $\frac{1}{4}$, section 36, T19S, R3W.

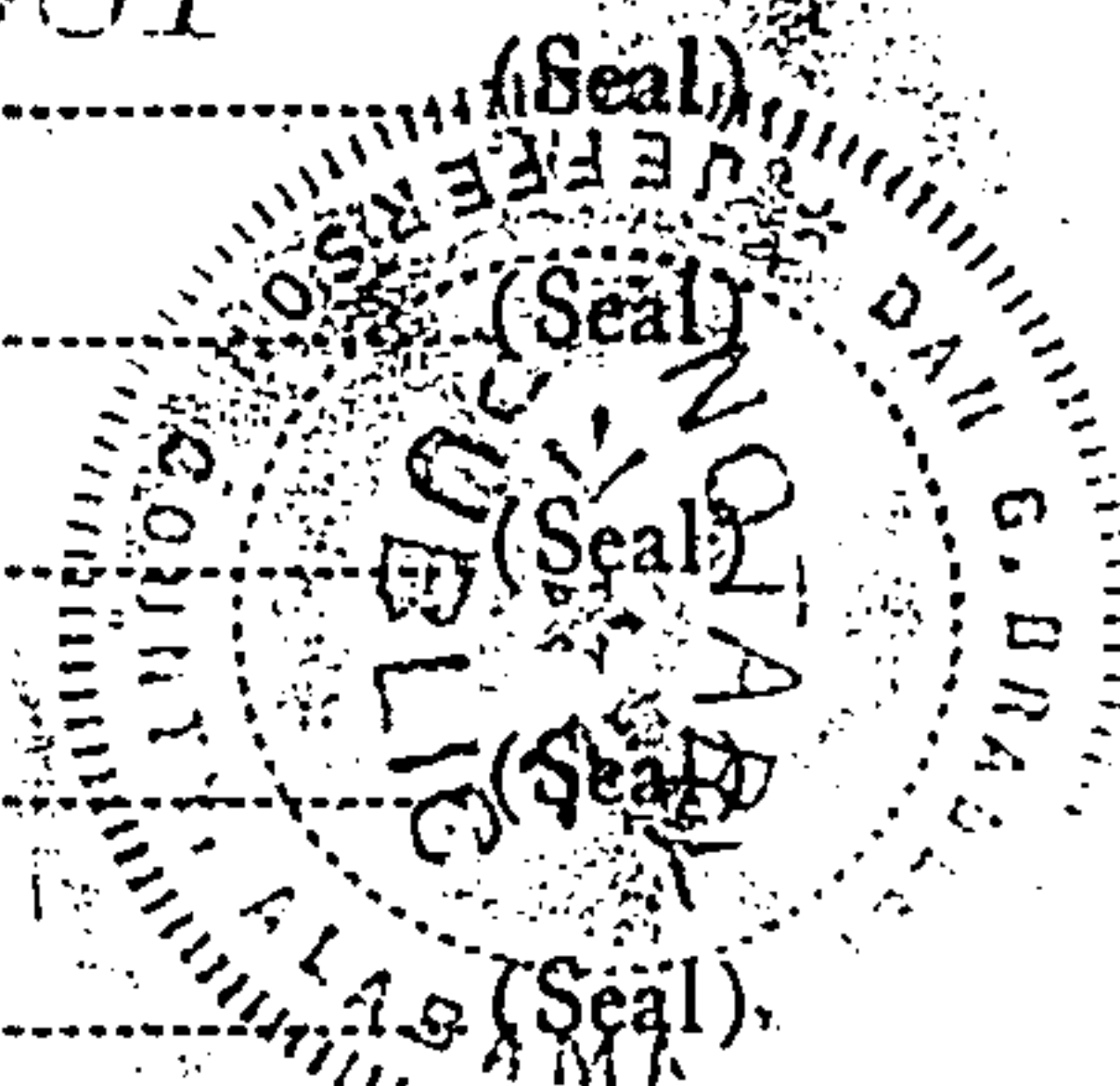
