the receipt whereof is acknowledged we the said B.A.Kendrick and wife, Mary Louise Kendrick, do grant, bargain, sell and convey unto the said William T.Syphurs and wife, Mary Lois Syphurs,

the following described real estate situated in Shelby County, Alabama, to-wit: Our undivided one-half interest in the following described real estate, to-wit: The Southeast Quarter of the Northwest Quarter of Section 21, Township 20, Range 1 West, fee simple interest.

The Northeast Quarter of the Southwest Quarter of Section 21, Township 20, Range 1 West, less Mineral Rights, EXCEPT one acre in said Northeast Quarter of the Southwest Quarter of said Section 21, described as beginning at the Southwest corner of said forty acres and run East 35 yards; run thence North 140 yards; run thence West 35 yards; run thence South 140 yards to the place of beginning.
