Affiant further says at the time he purchased said land, Mr. & Mrs. Hodgens had owned it and lived on the house situated on the N\(^12\) of NW\(^14\) of SW\(^14\) of said Section 1 and had been in possession of all of the above described land for more than 20 years and they had claimed to own the same and affiant had never heard of anyone disputing their ownership. Mr. & Mrs. Hodgens had portions of said land fenced in and they cultivated portions of it and obtained rirewood from portions of it each and every year while they owned it. Upon having it called to affiant's attention that W. N. Hodgens purchased the N\(^12\) of NW\(^14\) of SW\(^14\) of said Section 1 in 1902 from J. E. Hodgens and his wife, S. E. Hodgens, as shown by deed recorded in Deed Book 27 Page 255 in said Probate Office, affiant says that it is his recollection that W. N. Hodgens and his wife S. E. Hodgens owned or were in possession of the remainder of the above described land at about the same time as that purchased from J. E. Hodgens and his wife in 1902, as mentioned above.

Boothe in 1923 to the time they sold it to affiant, as mentioned above. Affiant further says that Martha J. Boothe owned said land as far back as he can remember, which was possibly some 40 to 50 years ago and the said Martha J. Boothe cultivated the land throughout the years she owned it and affiant has never heard of anyone contesting the possession or disputing the title of said persons to said 20 acres described in this paragraph.

Affiant further says that W.N. Hodgens was one and the same person as Walter N. and Hodgens and his wife, S. E. Hodgens was one/the same person as Salena E. Hodgens.

Affiant further says that neither Scott Investment Company, Gaston Scott nor W. W. Powers nor anyone else to his knowledge ever drilled for oil on any of the above described land.

Affiant further says that on September 27, 1954, to his own knowledge, Mrs. Lorene Ray was a widow.
