KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned Lelia Evans, a widow, Oner C. Evans and wife Peggy Evans, Clifford James Evans, Sr. and wife Parnell Evans, Sam A. Evans and wife Estelle Evans and Pauline Evans Allen and husband Alfred Allen, do hereby dedicate the following property for a public road for the benefit of J. C. Jones and the public generally, viz:

Eighteen feet on the East side of a line described as follows: commence at the NW corner of NW fractional Section 27, Township 22 South, Range 3 West, and run thence South 640 feet to SW corner of said NW Fractional Section, thence 72° to the Left 61 feet to the point of beginning of the line adjacent to where said 18 foot right of way lies; from said point of beginning, run 81° 30' to the right 194 feet, thence 1° 20' to the Right 102 feet, thence 23° 30' to the Right 67 feet to a private road.

This deed is executed to afford an outlet or right of way for J. C. Jones and his successors in title over what is known as the Evans property in Beat 4, Shelby County, Alabama, and will be in lieu of all other roads or rights of way over what is known as the Evans property, a portion of which J. C. Jones heretofore acquired.

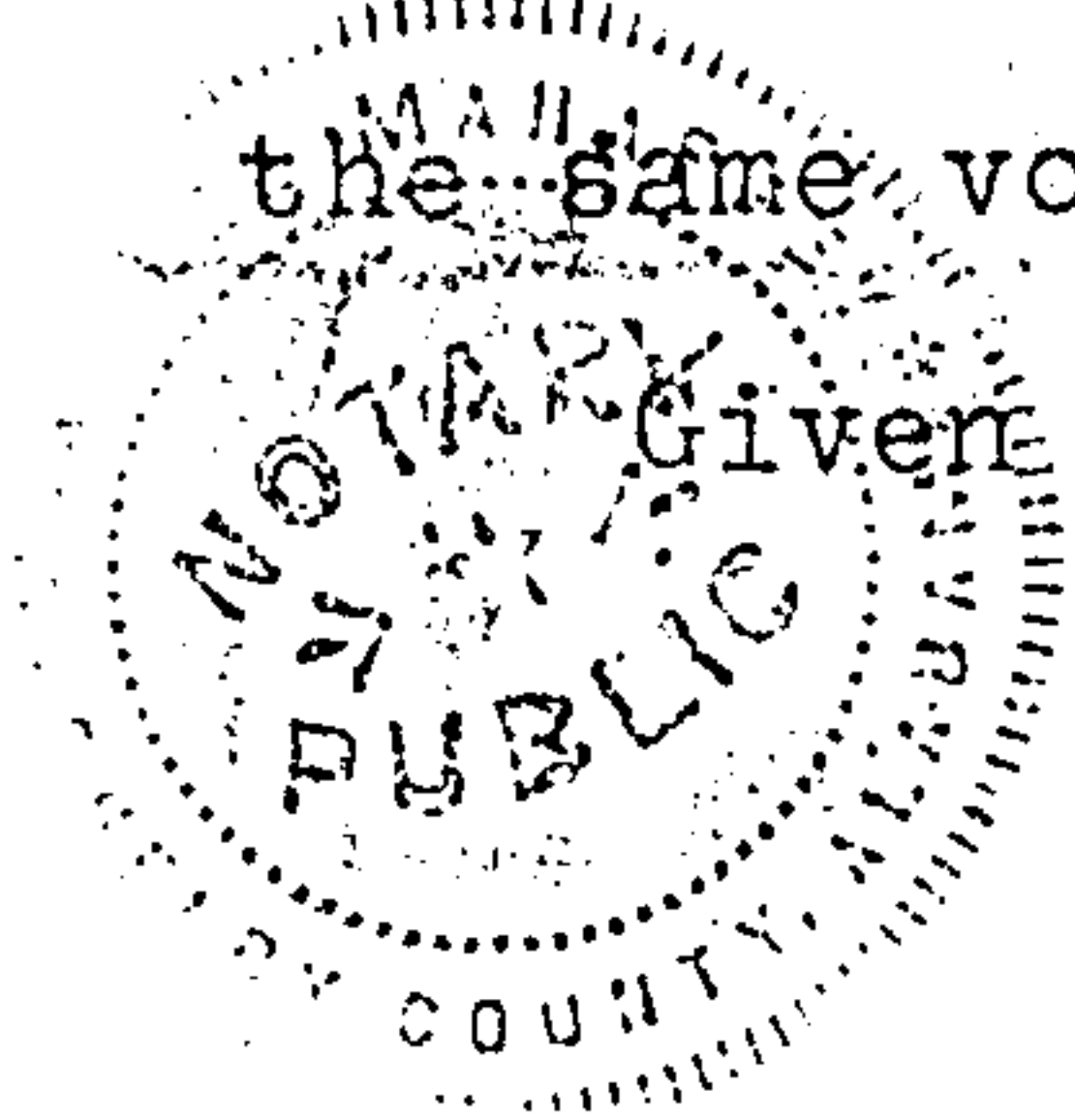

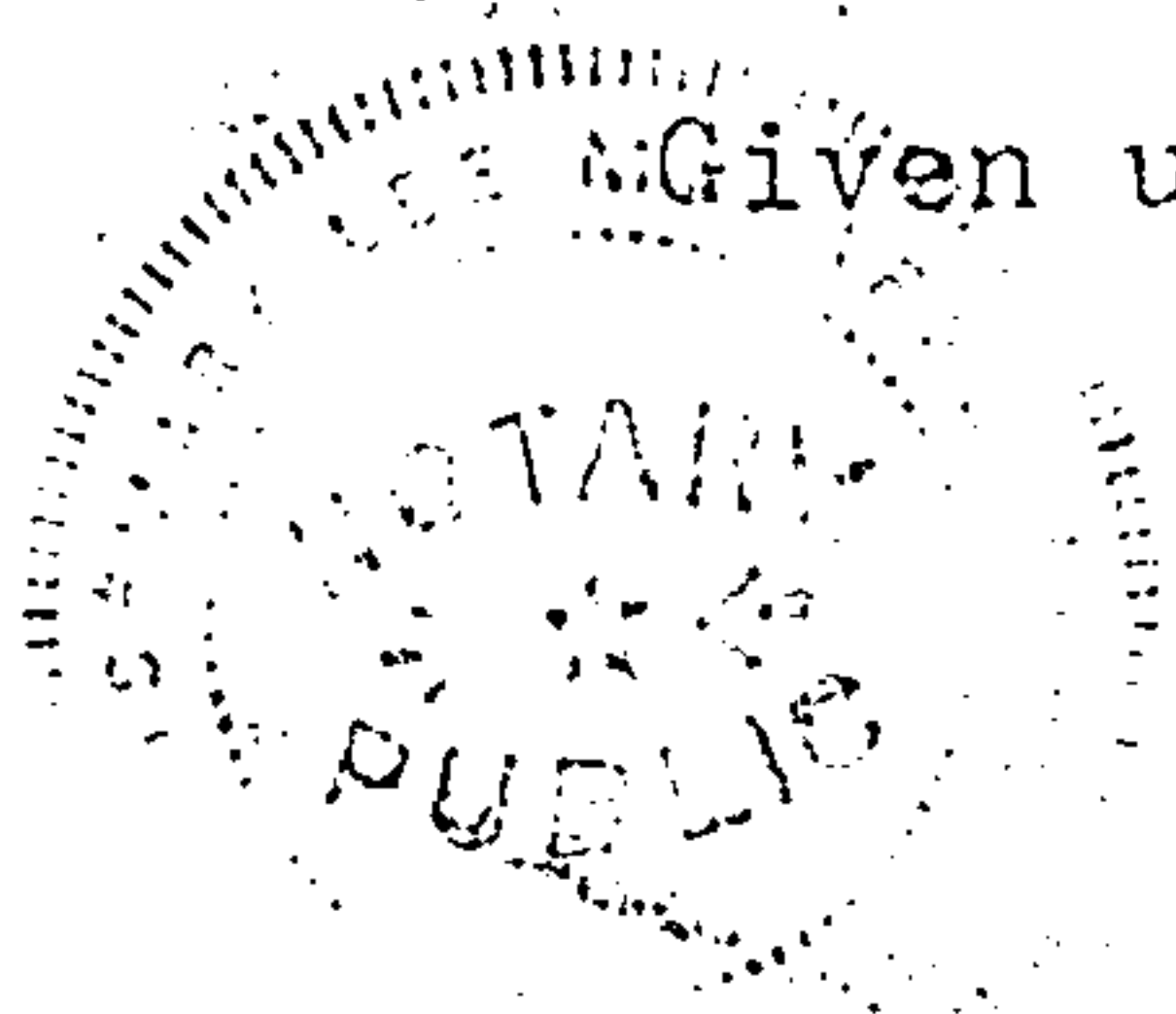
