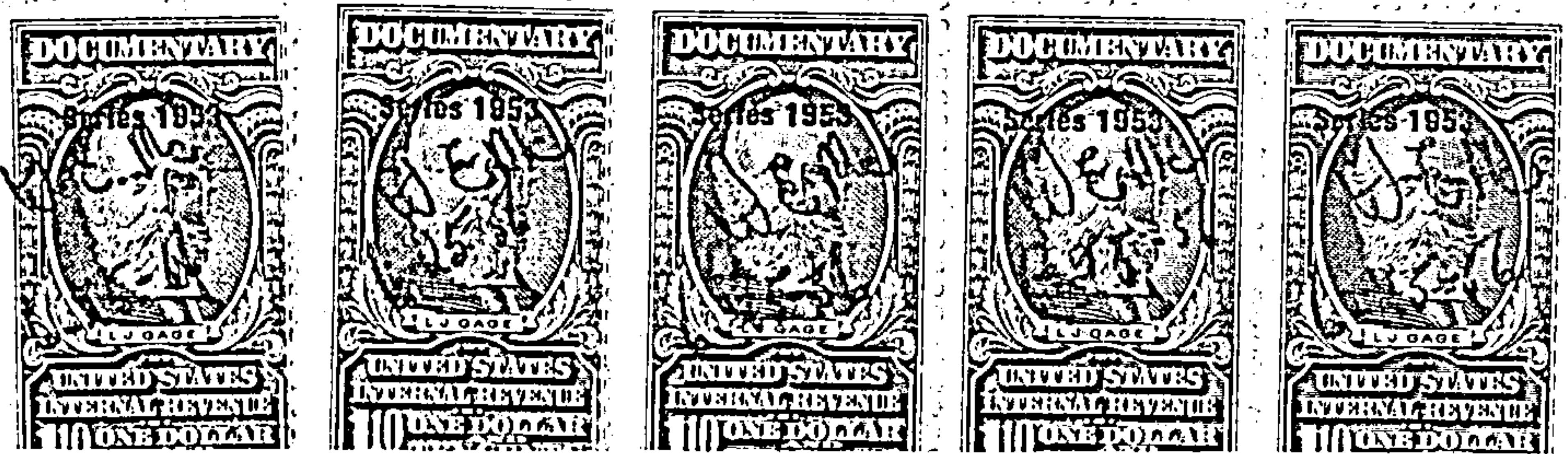
That in consideration of ONE ----- DOLLARS

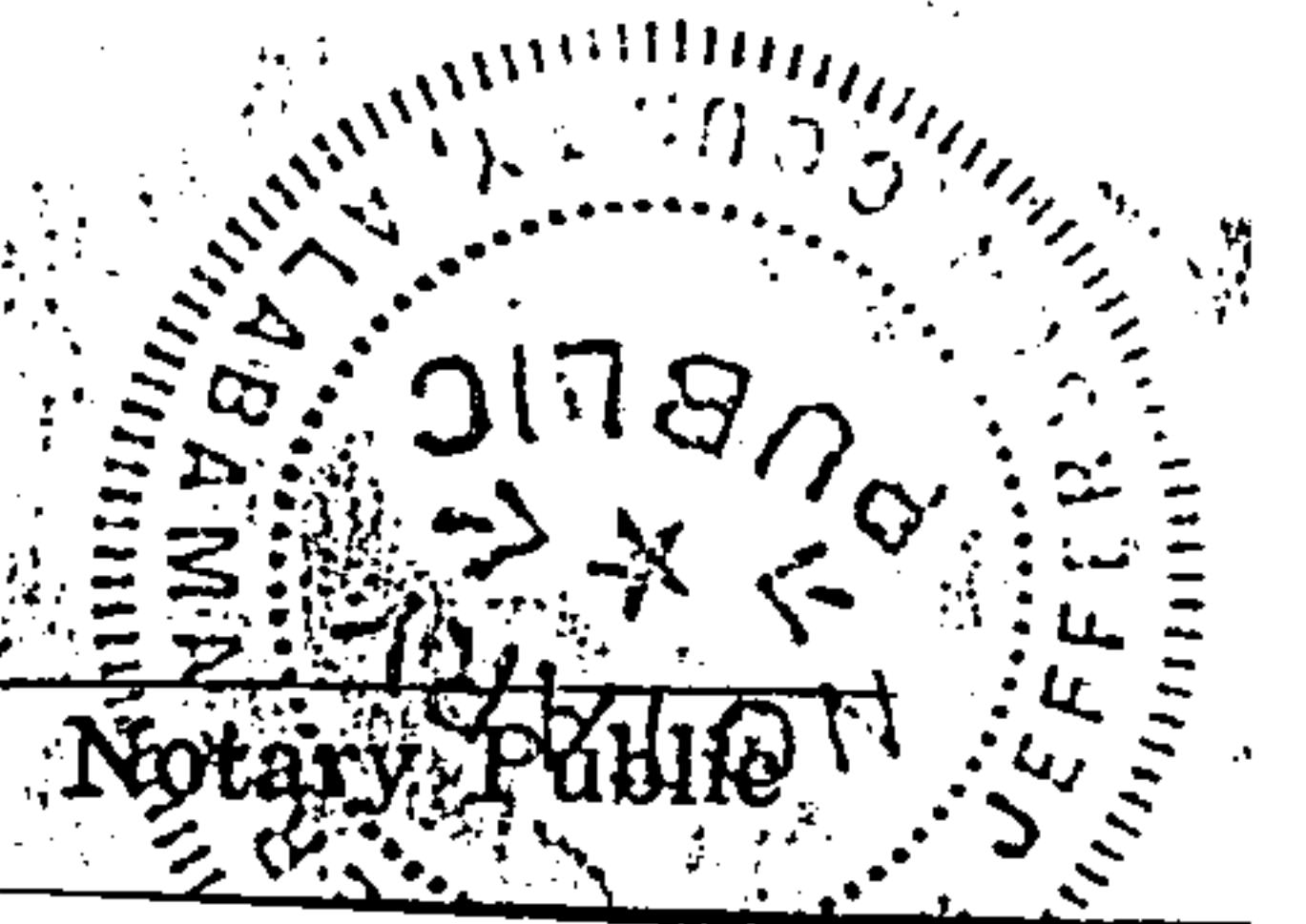
