DECREE REMOVING DISABILITIES OF NON-AGE

OF

JERRY JACKSON CHESSEY

THIS CAUSE, now coming on to be heard is submitted for a final decree upon petition, notice, and the oral testimony before the Court of Mary Margaret (Mrs. L. P.) Chesser, Robert S. Richard, Esq. and Jerry Jackson Chesser; and upon consideration thereof, the Court is of the opinion and finds that all the allegations of the petition are true; that the said Jerry Jackson Chesser is a minor over 18 years of age and under the age of 21 years; that he is a resident of Shelby County, Alabama residing at Sterrett and is for his age a person of mature judgment, of sober and industrious habits, and is competent and capable in everyway of handling his own affairs, and is the owner of property; that Mary Margaret (Mrs. L. P.) Chesser is the mother of Jerry Jackson Chesser and that the father of Jerry Jackson Chesser, L. P. Chesser, is totally incapacitated by reason of injuries sustained in an automobile accident on July 24, 1955; the Court further finds that it is to the interest of such minor to grant the prayer of his petition and it is,

ORDERED, ADJUDGED AND DECREED by the Court:

(1) That the said Jerry Jackson Chesser be and he hereby is relieved from the disabilities of non-age unconditionally and without restriction and he hereby is vested with the right to sue and be sued, contract, buy, sell and convey real estate and in general to do and perform all acts and things which she could lawfully do if he were 21 years of age.

(2) That the said Jerry Jackson Chesser file a certified copy of this decree in the Office of the Probate Judge of Shelby County, Alabama, and in each of the Counties in which said minor shall hereafter reside, and in the Office of the Probate Judge in each county in the State of Alabama where the said minor shall do any business or make any contracts.

(3) That the petitioners pay the cost of these proceedings to be

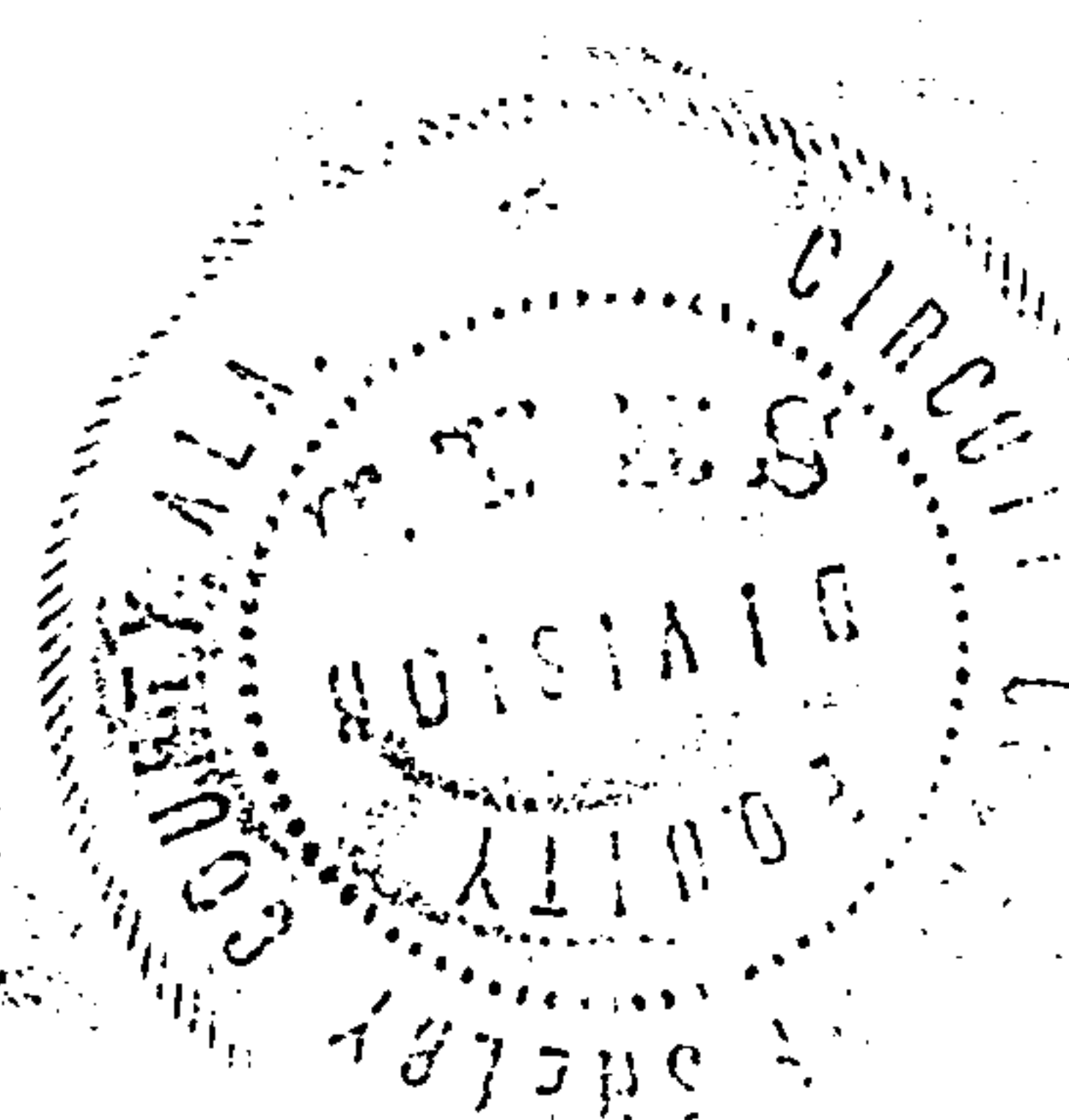
