Davis and Wilda Davis, all its right, title, interest and claim in or to the following described real estate, to-wit:

Beginning at the southwest corner of SE $\frac{1}{4}$ of NW $\frac{1}{4}$ and running east 55 yards; thence north 198 yards to Saginaw Public Road; thence southwest along said road 66 yards; thence south 155 yards to point of beginning, containing 2 acres, more or less, being situated in SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 14, Township 21, Range 3 West, Shelby County, Alabama.

TO HAVE AND TO HOLD, to the said A. H. Davis and Wilda Davis, their heirs and assigns forever.

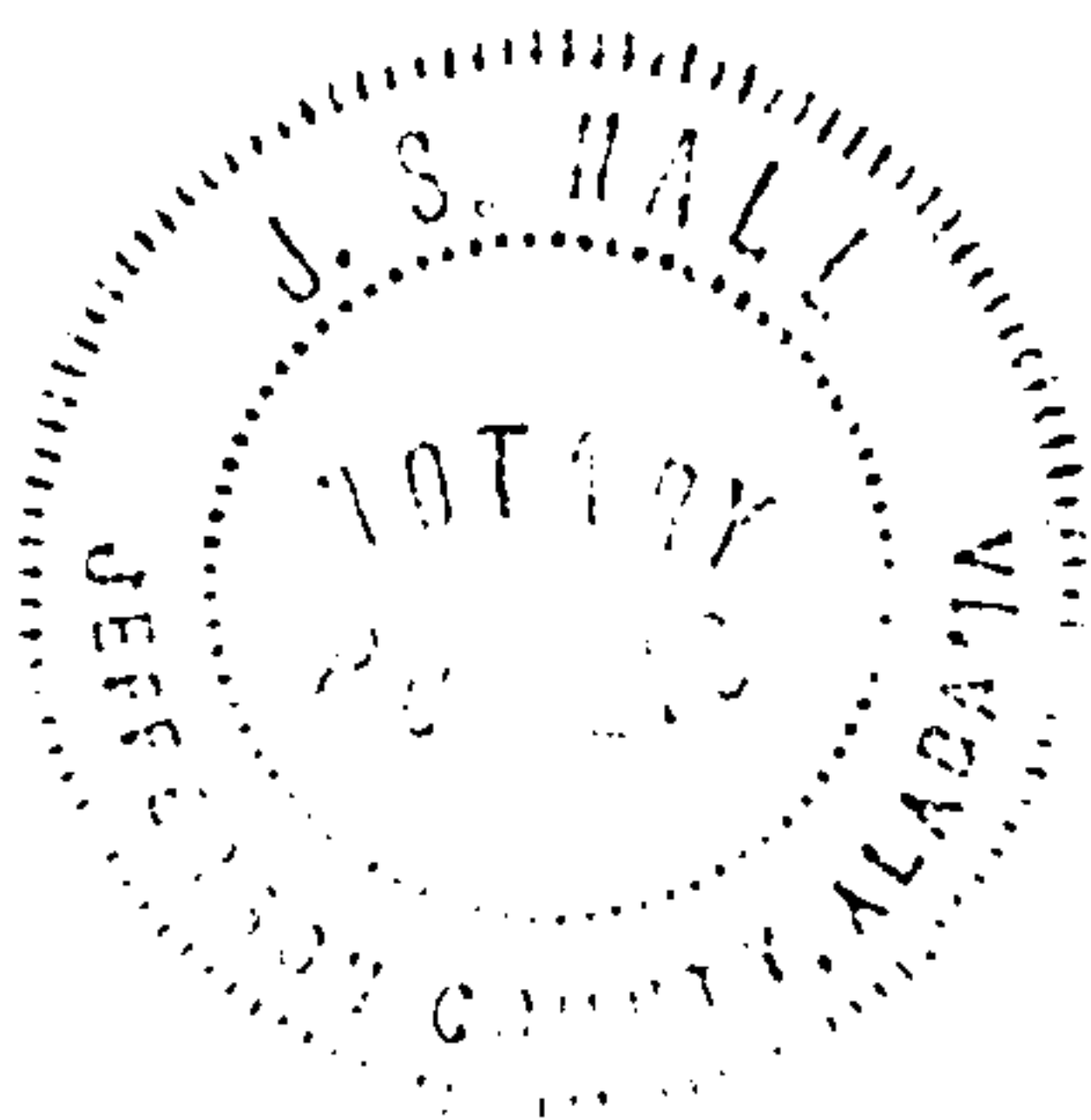
