That I am the widow of G. H. Stewart, Jr.; that I have been acquainted with the ownership, use and possession of the following described property in Shelby County, Alabama, for more than twenty-five years, last past:

 W_2^1 of NW_4^1 , Section 7, Township 21, Range 2 East; the NE_4^1 of NW_4^1 , Section 1, Township 21, Range 1 East; the SE_4^1 of SE_4^1 , Section 1, Township 21, Range 1 East; All that part of the NW_4^1 of SE_4^1 , Section 1, Township 21, Range 1 East; that lies south of the Southern Railway right of way and west of the Montgomery Road right of way;

Also, a lot in the $NE_4^{\frac{1}{4}}$ of $SE_4^{\frac{1}{4}}$, Section 1, Township 21, Range 1 East, described as follows: Begin at the SW corner of said $NE_4^{\frac{1}{4}}$ of $SE_4^{\frac{1}{4}}$ and run thence north along the west boundary of said Quarter-Quarter section to the south right of way line of the Southern Railway; thence northeast along said right of way 120 yards to NW corner of James A. & Audrey E. Snoddy lot; thence south along the West line of said Snoddy lot to the Montgomery road right of way, thence southwest along north right of way line of said Montgomery Road to point of beginning.

Also, a lot in the NE_4^1 of SE_4^1 , Section 1, Township 21, Range 1 East, described as commencing at the southwest corner of said NE_4^1 of SE_4^1 and run Easterly along the south boundary of said Quarter-Quarter section 215 feet; thence in a Northwesterly direction 143 2/3 feet to an iron stake in the center of a public road; thence along said public road 207 feet and 5 inches to point of beginning.

My husband, G. H. Stewart purchased the above described land, and other land on July 5, 1929 from James J. Smith as Trustee in Bankruptcy of S. C. Taylor, which said deed is recorded in the Probate Office of Shelby County, Alabama in Deed Book 95, page 213. Upon the execution and delivery of such deed, my husband, and I and my daughter, Carolyn Isbell Stewart, whose name is now Carolyn Isbell Stewart Motes, moved onto the land and farmed the land each and every year. In 1941 the large house on the above described property burned and I built another house on the land where I continued to live. My husband, G. H. Stewart, Jr. died in the year 1940. After the death of my husband, I continued to occupy the house on the land as a residence and continued to have the land farmed under my supervision each and every year thereafter until 1950 when I moved to Sylacauga. While my husband and I occupied the above described land one child was born to us whose name is Shirley Ann Stewart, and at the time of my husband's death

my two above named daughters and myself constituted the next of kin and sole surviving heirs at law of G. H. Stewart, Jr. and of this date are each over the age of twenty one years.

After I moved to Sylacauga in 1950, I continued to rent the farm each and every year thereafter and the land was continuously farmed by my tenants each and every year and in fact, a tenant of min is on the place as of this date.

The lines of the above described property are clearly marked, the wooded land being fenced, and the open land being cultivated and the land has been in cultivation by me and my husband and under my supervision for more than twenty five years last past. The land has been assessed for taxes and taxes duly paid thereon by my husband during his lifetime and by me since his death each and every year since we purchased the land in 1929. During the time my husband and I owned this land we have been in the actual, exclusive, open, notorious, hostile and continuous possession of the land and have never heard the title of my husband questioned in any way and as far as I know, there is no adverse claims of any kind by any person against such land.
