TO HAVE AND TO HOLD, to the said Nellie Vogalo, and unto her heirs and assigns forever.

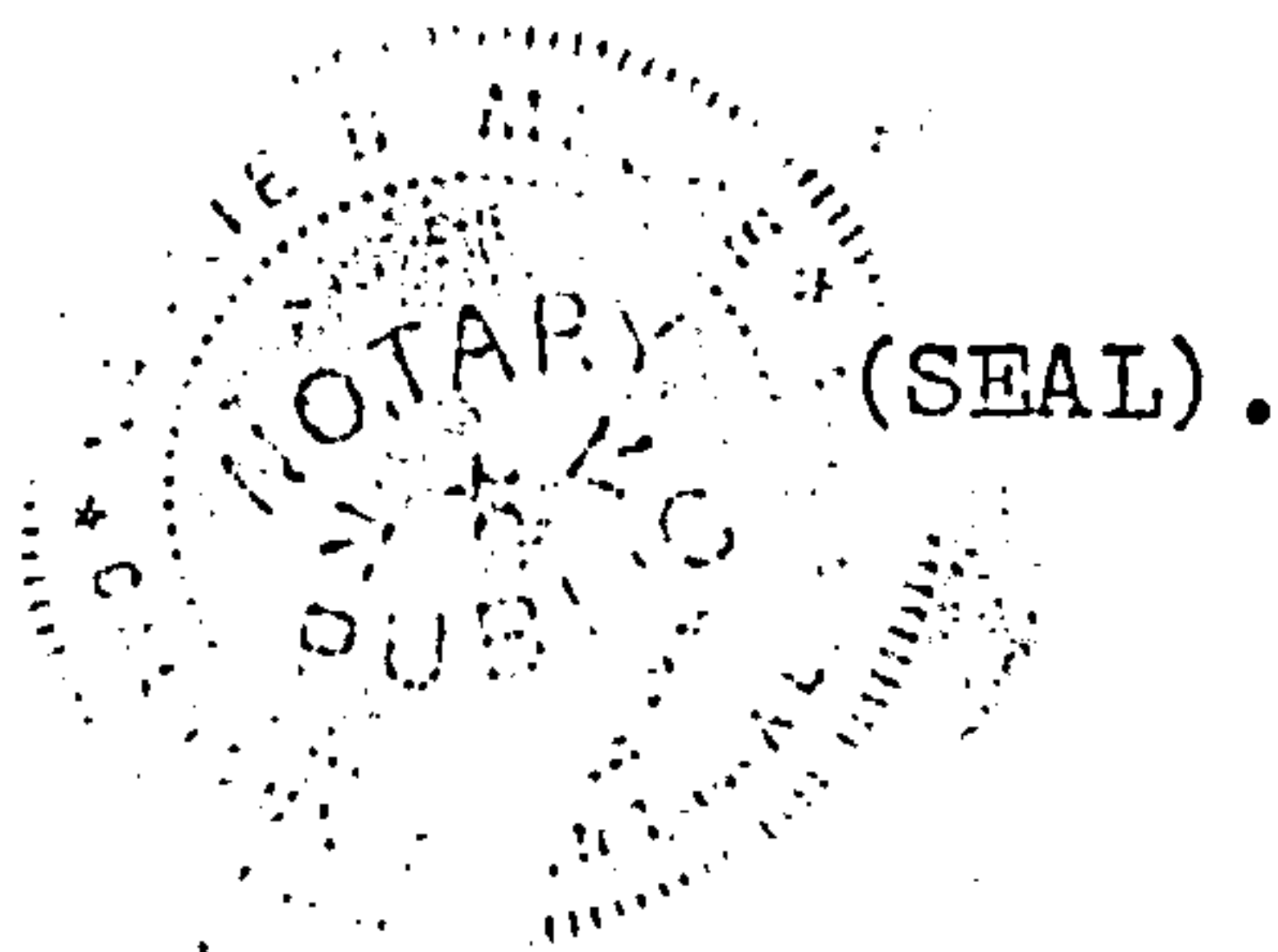
