WITNESSETH: That for and in consideration of the sum of SIXTY DOLLARS (\$60.00) in hand paid to the party of the first part, by the party of the second part, the receipt whereof is hereby acknowledged, the party of the first part has granted, bargained, and sold, and by these presents, does grant, bargain, sell and convey unto the said party of the second part all and singular that parcel or strip of land situate, lying, and being in the County of Shelby, State of Alabama, to-wit:

All that certain strip or parcel of land situate, lying and being in the Northeast Quarter of the Northeast Quarter of Section 34, Township 19, South, Range 1 West, in Shelby County, Alabama, and described as follows:Beginning at a point on the Southeasterly boundary line of the Atlantic Coast Line Railroad Company's present right of way, which right of way is 50 feet wide on each side of the center line of said Railroad Company's main track. Said point being in the run of Yellowleaf Creek; running thence Southeastwardly along the run of said Creek to a point 75 feet Southeastwardly, measured at right angles, from said center line; run thence Southwestwardly, parallel with said center line, 435 feet, more or less, to the East line of said Railroad Company's Section House Lot; thence Northwestwardly along said East line 25 feet, more or less, to said boundary line; run thence Northeastwardly along said boundary line 410 feet, more or less, to the point of beginning; and containing 0.24 of an acre, more or less, and being shown in red on the blue print hereto attached and made a part hereof and marked Exhibit "A" to this deed.
