ITEM ONE: I direct that all of my just debts including the expenses of my last illness and funeral expenses, be paid by my Executrix as soon after my death as may be found practicable, this expense is to be paid out of my checking account as shown to my credit in the Main Branch of The First National Bank of Birmingham, Birmingham, Alabama; if there is not enough monies in said checking account to pay these expenses, then I direct that the Executrix of this MY LAST WILL AND TESTAMENT, use any additional funds out of the savings account to my credit at the First National Bank, Birmingham, Alabama, (Main Branch) to liquidate any just debts that I may owe.

ITEM TWO: The stock I own in the Coosa Valley Cooperative Gin Association, I give, will and bequeath to W. Stanley Jones, Jr.

ITEM THREE: I give, will, devise, and bequeath unto W. Stanley Jones, Sr. and Mrs. Kathryn Florey Jones, the farm I own near Harpersville, Alabama, and described as follows:

The Northwest Quarter of the Southeast Quarter, and the North Half of the Southwest Quarter of the Southeast Quarter and the Southeast Quarter of the Southeast Quarter, all in Section 34, Township 19, Range 2 East, containing one hundred (100) acres, more or less, situated in the County of Shelby, State of Alabama.

ITEM FOUR: I have two accounts in the First National Bank of Birmingham (Main Office), one, a checking account, and the other a savings account. The funds in said checking account to my credit at the time of my death, I give, will, devise and bequeath to Kathryn Florey Jones with the

exception of any money needed to pay my just debts as described in ITEM ONE; and of the funds in the savings account to my credit at the time of my death, at said Bank, I give, will, devise and bequeath unto Henry E. Florey, a sum equal to ten per centum (10%) of any amount shown to my credit in said savings account at said bank at the time of my death. The remainder of said funds in said savings account, I give, will, devise and bequeath unto Kathryn F. Jones.

ITEM FIVE: I give, will and bequeath to Kathryn Florey Jones, the stock I own in the Alabama Power Company valued @ five hundred dollars (\$500.00) and I give, will and bequeath to Sara Marilyn Jones, the stock I own in the Alabama Power Company valued @ one thousand dollars (\$1,000.00).

ITEM SIX: All the rest and residue of my property, whether real, personal or mixed, I give, will, devise and bequeath unto my niece, Mrs. Kathryn F. Jones, to be hers absolutely.

ITEM SEVEN: I hereby nominate, constitute and appoint Kathryn F. Jones as Executrix of this MY LAST WILL AND TESTAMENT, and hereby direct that she not be required to make any bond as such, or to make any account of her acts and doings hereunder.
