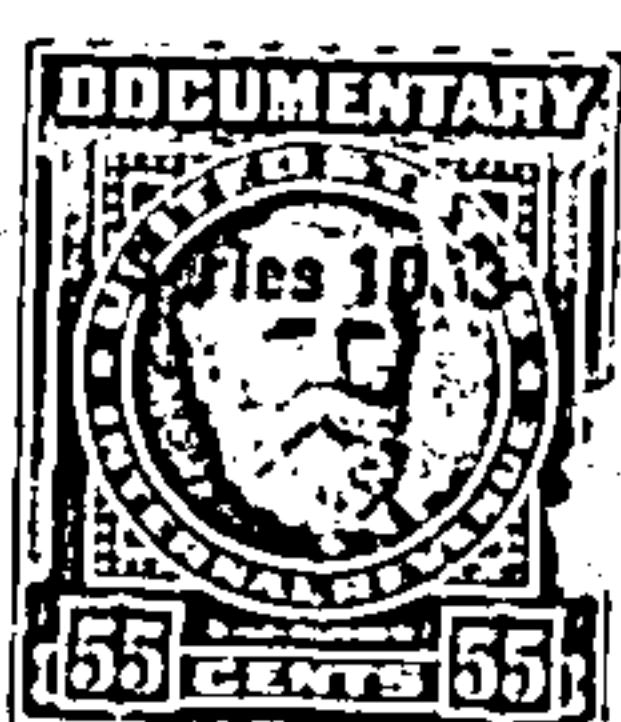
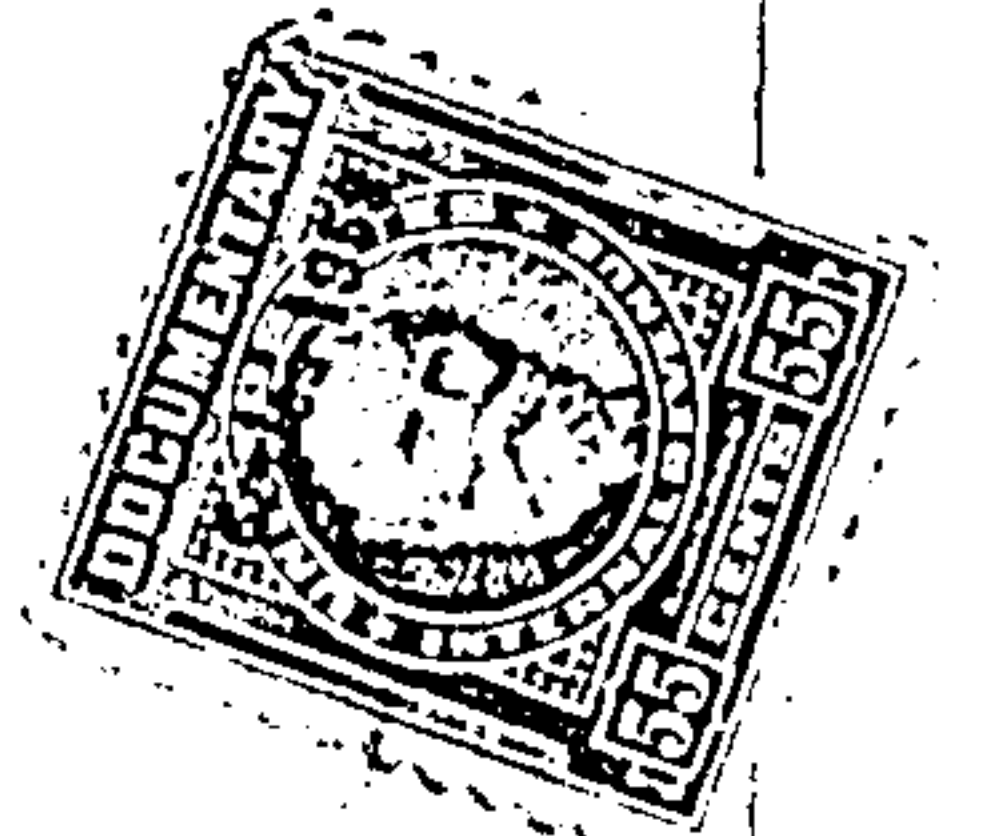
TO HAVE AND TO HOLD, To the said E. J. Glass, his heirs and assigns forever.

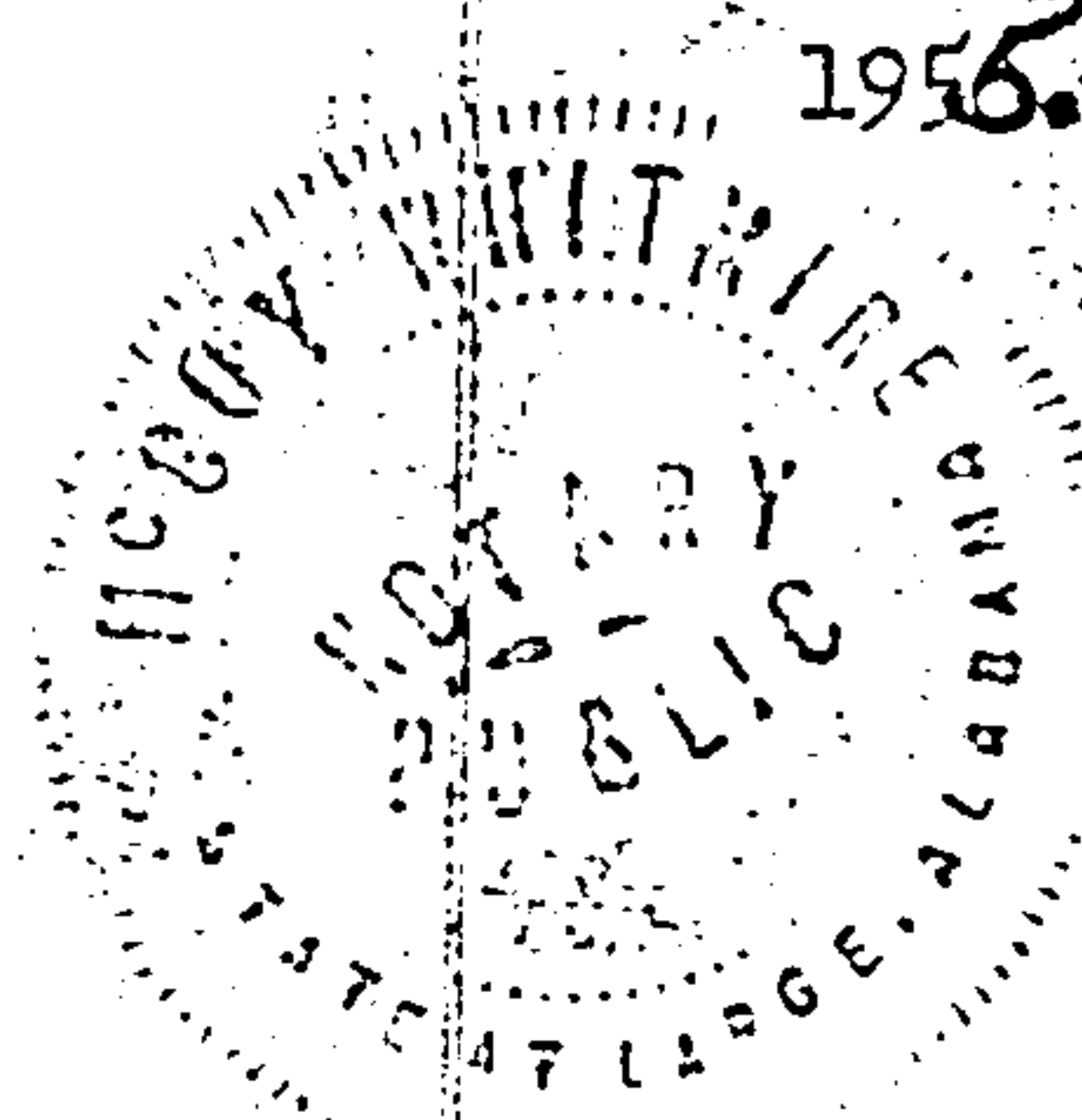
