LAST WILL AND TESTAMENT OF
CHARLIE H. TRUCKS

KNOW ALL MEN BY THESE PRESENTS, That I, Charlie H. Trucks, of Birmingham, Jefferson County, Alabama, being of sound mind and over the age of 21 years, do make and publish this my Last Will and Testament, hereby revoking all former Wills by me at any time heretofore made.

As to all my worldly estate, and all the real, personal or mixed property of which I shall die seized and possessed, or to which I shall be entitled at the time of my decease, I do hereby devise, bequeath and dispose thereof in the manner following, to-wit:

1. My Will is that all my just debts and funeral expenses shall, by my Executor hereinafter named, be paid out of my estate as soon after my decease as convenient.

2. I give, devise and bequeath to my beloved Son, Jesse H. Trucks, any and all property, including any and all real, personal or mixed property of which I shall die seized and possessed, or to which I shall be entitled at the time of my decease, absolutely in fee simple.

3. I do hereby nominate and appoint my beloved Son, Jesse H. Trucks, to be the Executor of this my Last Will and Testament, and I direct and request that he be exempt from and not required to enter into Bond as such Executor and I further direct and request that he be exempt from and not required to file any Inventory or Accounting to any Court and further that he be exempt from and not required to make any Report or Final Settlement to any Court.

In Testimony Whereof, I, the said Charlie H. Trucks, have to this my Last Will and Testament, subscribed my name and affixed my seal, this the
