to the undersigned grantor S. J. G. Lacey and wife, Lillian S. Lacey,

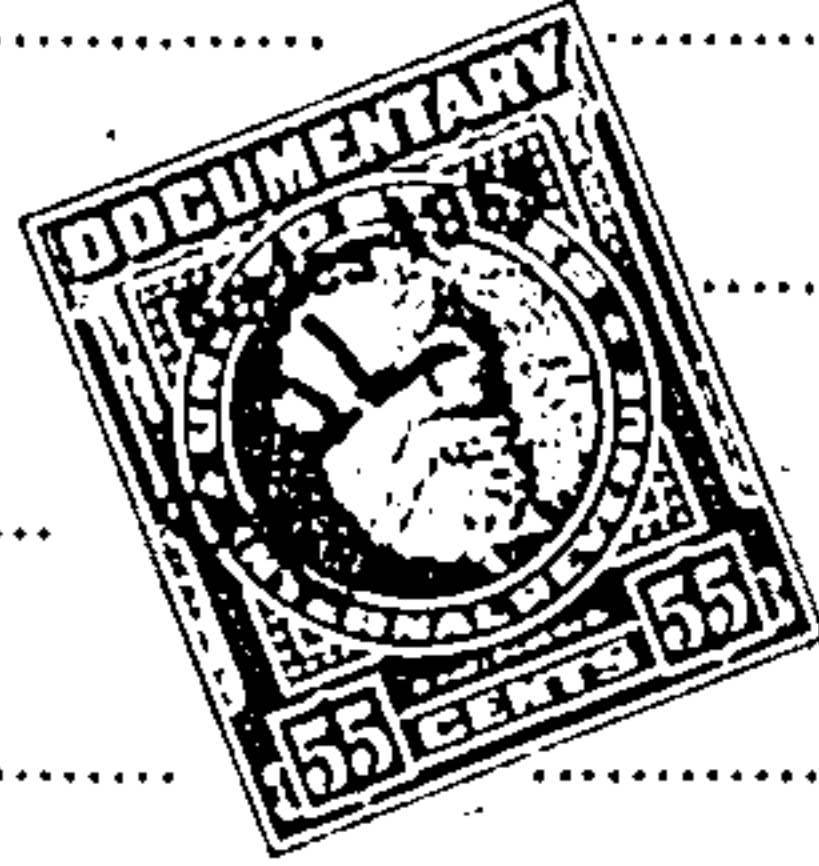
