Caddell, as members thereof, for and in consideration of the sum of Five and No/100 Dollars (\$5.00) to it in hand paid by Victor Scott, the receipt whereof is hereby acknowledged, does hereby remise, release, and forever quit claim unto the said Victor Scott, all its right, title and interest in and to the following land lying and being in the County of Shelby, State of Alabama, and particularly described as follows, to-wit:-

Commencing at the SE corner of the NE $\frac{1}{4}$  of Section 4, Township 24, Range 12 East and run North 64 degrees 5 minutes West 243.3 feet to the South boundary of the right of way of State Highway No. 25 for point of beginning of a lot herein conveyed; run thence south 18 degrees 45 minutes West 302.5 feet; run thence North 52 degrees 15 minutes West 165 feet, more or less to the southeast boundary of the right of way of State Highway No. 25; run thence in a northeasterly direction along the southeast boundary of said State Highway No. 25 to point of beginning, being situated in the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  and NE $\frac{1}{4}$  of SE $\frac{1}{4}$  of said Section 4, Township 24, Range 12 East, Shelby County, Alabama.

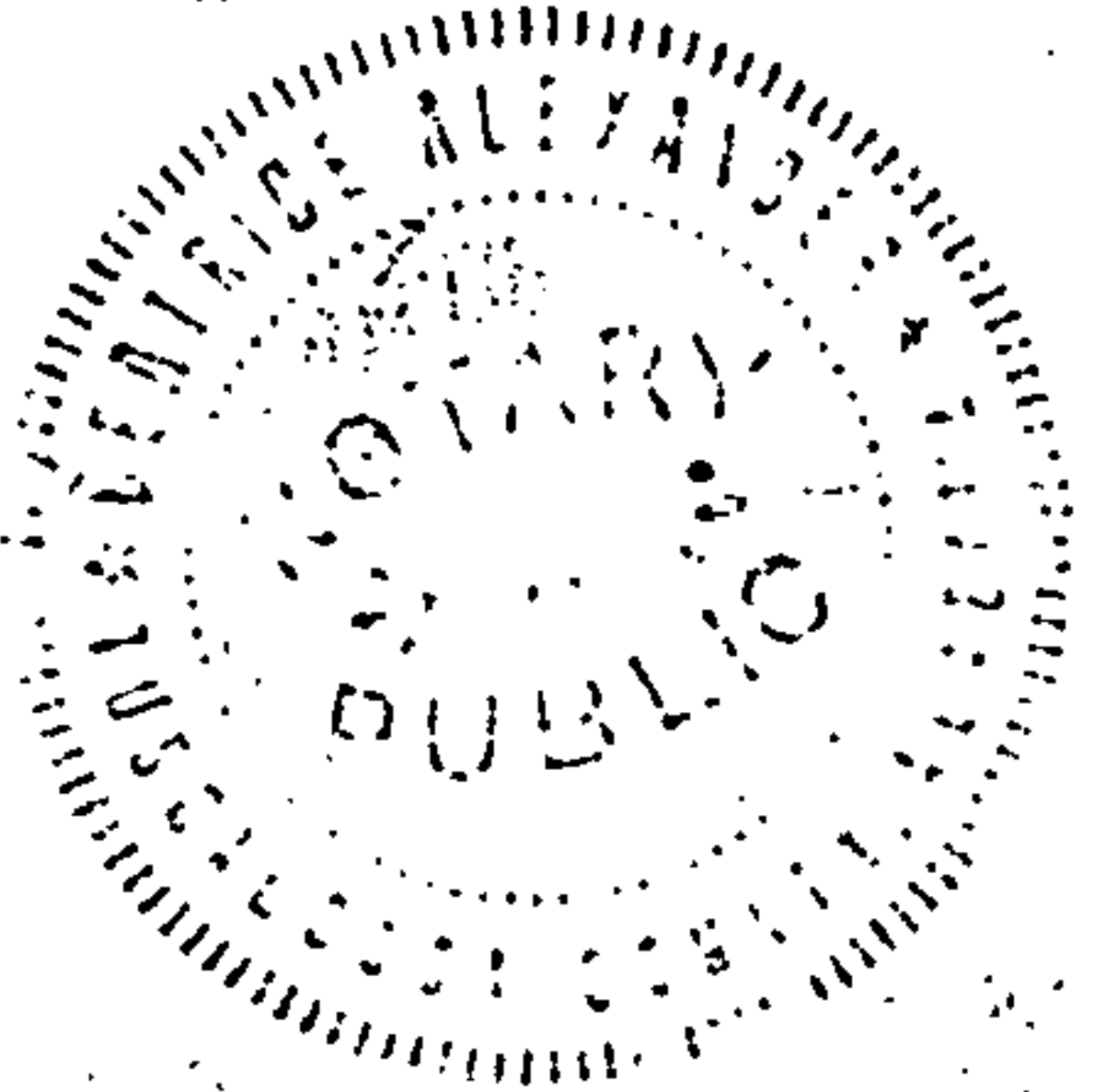
