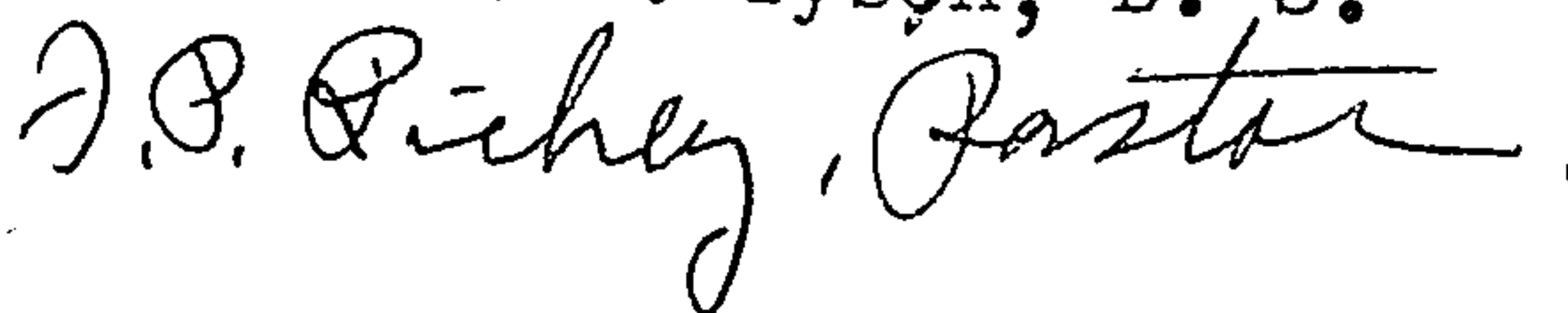

Chapter III Section 139 of 1952 Edition of the Discipline of the Methodist Church grants authority to District Superintendent to empower local pastor to hold Special Quarterly Conference.

WHEREAS, the Board of Trustees of the Columbiana Methodist Church has heretofore acquired fee simple title to the east 150 feet of the property owned by Mrs. W. W. Carter on Carter's Lane in Columbiana, Alabama for the purpose of erecting a new parsonage thereon and all of the purchase price for said lot has been paid; and

WHEREAS, the membership of the Columbiana Methodist Church has heretofore considered and given its approval for the construction of a new parsonage on said lot and notice of more than ten days has been given from the pulpit of said Church of this Special Quarterly Conference at which, among other things, authorization for the construction of said new parsonage for the Church would be sought; and

WHEREAS, the District Superintendent of the Sylacauga District of the North Alabama Conference of The Methodist Church, L. D. Tyson, has in writing directed F. P. Richey, pastor of the Columbiana Methodist Church, to hold said Special Quarterly Conference on this the 10th day of June, 1956 and he has also given written consent for the construction of said new parsonage.

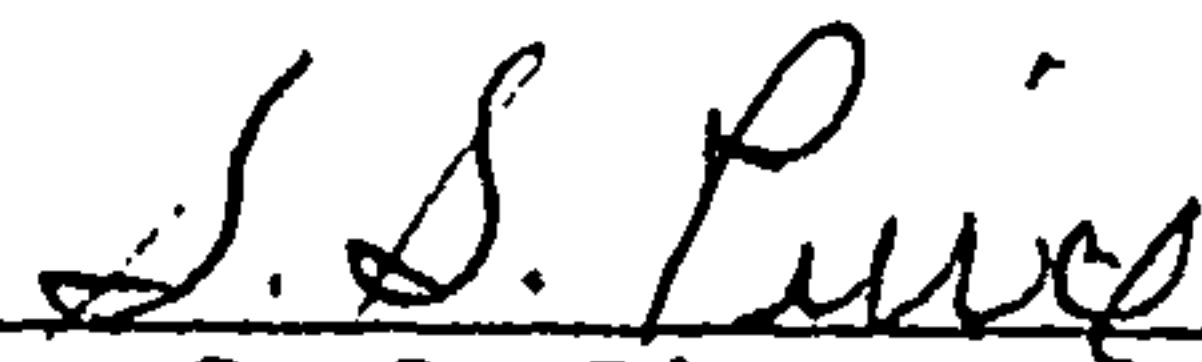
NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

ONE: That the Quarterly Conference of the Columbiana Methodist Church authorize the construction of a new parsonage for said church.

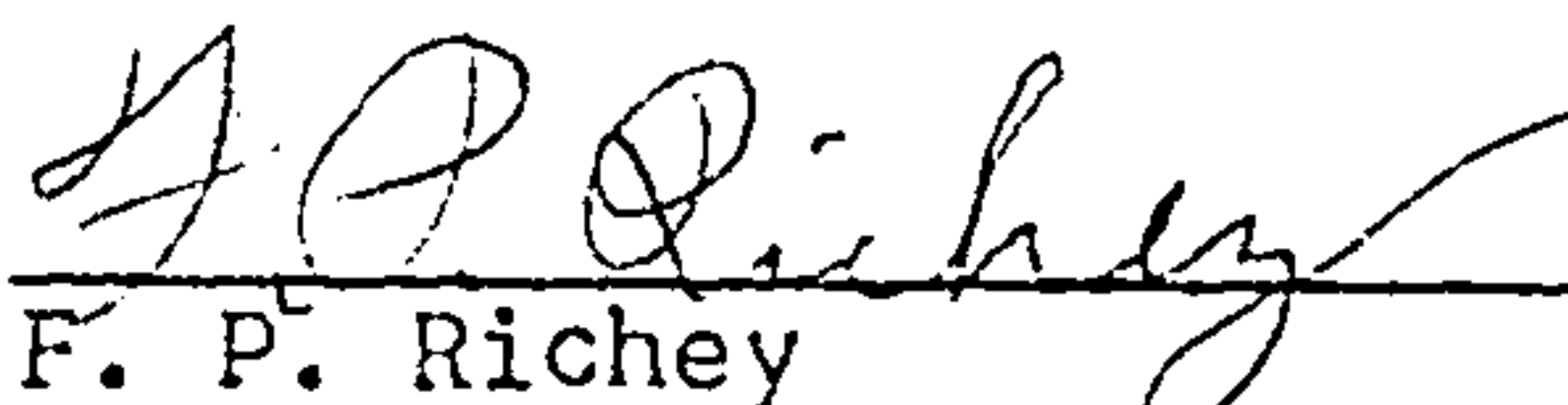
TWO: That a committee of not less than three members of such Church shall be elected by the Quarterly Conference and this committee shall be known as the Building Committee and it shall have committed to it the full responsibility for the erection of said parsonage and the improvement of the grounds upon which said parsonage shall be situated, the total sum to be expended for such purpose to be approved by the Board of Trustees.

WHEREAS, the Special Quarterly Conference of the Columbiana Methodist Church, Columbiana, Alabama, has authorized the construction of a new parsonage for said Church; and

WHEREAS, at least fourteen days notice of the meeting of said Special Quarterly Conference was given from the pulpit of said Church and it was announced at the time of the giving of said notice that said Quarterly Conference would consider selling the parsonage now in use by the pastor of the Columbiana Methodist Church to finance the construction of a new parsonage and also would consider the borrowing of funds to defray the further cost of the construction of such new parsonage; and

WHEREAS, at the time said notice was given it was stated that said Special Quarterly Conference would be held in the Columbiana Methodist Church following the evening worship hour on June 10, 1956; and

WHEREAS, the members of the Columbiana Methodist Church have contributed several thousand dollars to a fund for the construction of such new parsonage; but that the sum so contributed together with the proceeds realized from the sale of the present parsonage will be insufficient to defray the cost of construction of such new parsonage and it will be necessary to borrow an additional sum to finance said construction.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

One: That the Quarterly Conference of the Columbiana Methodist Church, Columbiana, Alabama hereby authorize the Board of Trustees of said Church to sell the parsonage now in use by the pastor of said Church, the proceeds of said sale to be used solely for the purpose of financing the construction of the proposed new parsonage; said sale to be for an amount and according to such terms as shall be approved by the Board of Trustees.

Two: That the Quarterly Conference of the Columbiana Methodist Church hereby authorize the Board of Trustees of said Church to negotiate loans, the amounts and terms thereof to be determined by said Board of Trustees, and secure said loans by a mortgage on said new parsonage property and/or the property on which the Columbiana Methodist Church is now situated; said Board of Trustees to also have full authority to renegotiate any Church indebtedness in any manner deemed by said Board to be in the best interest of said Church; any such loan so obtained to be for the purpose of financing the construction of said new parsonage or for the refinancing of any Church debt.

Three: That any two of the officers of said Board of Trustees are hereby directed by the Quarterly Conference to execute any deed, contract of sale or mortgage in pursuance of the authority granted in numbered paragraphs one and two above, as is provided in Section 171, paragraph 4 of the Discipline of the Methodist Church, 1952.

Four: That the written consent of the pastor of the Columbiana Methodist Church and of the District Superintendent of such Church shall be obtained and affixed to any deed, contract of sale or mortgage executed in furtherance of the authority granted by this resolution prior to the delivery of said paper as is provided in Section 171, paragraph 3 of the Discipline of the Methodist Church, 1952.
