All that part of the West Half of the Northwest Quarter of the Southeast Quarter, which lies North of Buck Creek; Also, all that part of the Northeast Quarter of the Southwest Quarter, which lies North of Buck Creek and East of Montevallo-Siluria Highway right of way, excepting l acre known as Benton Cemetery, and also, excepting 1/4th. of an acre sold to Emma Benton, as described in Deed Book 94, on page 320, in the office of the Judge of Probate of Shelby County, Alabama. All situated in Section 11, Township 21, South, Range 3 West, in Shelby County, Alabama.

Affiant further says that when he first knew the above described lands, said lands were owned and occupied by A.E.
