Further deposing, affiant says that W. P. Eason, Jr., one of the grantees in the above referred to deed from A. B. Baxley and wife, Jewel Baxley dated April 7, 1928 was his uncle and W. P. Eason, Sr. died sometime prior to 1928 and that in 1931 W. P. Eason, Jr. went by the name of W. P. Eason and affiant knows of his personal knowledge, that W. P. Eason, one of the grantors in that certain deed to C. T. Ingram dated May 30, 1931, recorded in the Probate Office of Shelby County, Alabama in Deed Book 89, page 387 is one and the same person as W. P. Eason, Jr., the grantee in that certain deed from A. B. Baxley and wife Jewel Baxley referred to above. Further deposing, affiant says that Marion Eason Jones, one of the grantees in the above referred to deed from A. B. Baxley and wife, Jewel Baxley dated April 7, 1928 is one and the same person as Marion E. Jones referred to by such name in deeds recorded in the Probate Office of Shelby

County, Alabama in Deed Book 136, page 468, deed Book 136, page 469, Deed Book 141, page 236 and deed book 141, page 237.

Further deposing, affiant says that a notice of tax lien recorded in the Probate Office of Shelby County, Alabama in Judgement Record D, page 455 has been called to his attention and affiant says that he knows of his own personal knowledge that no person by the name of Eason Jones has ever owned or claimed to own any part of the above described land, and he understands that such Eason Jones lived near Shelby, Alabama, and none of the people who have owned the above described land have ever lived in that vicinity.
