My name is James L. Ray, Jr. I am a registered land Surveyor, my registration No. being 1841. I am familiar with the following described lot:

Commence at the southeast corner of the SE¹/₄ of NE¹/₄ of Section 26, Township 21 South, Range 1 West; thence north, 2 degrees 58 minutes west, along the section line, a distance of 1061.79 feet to a point on north side of a concrete sidewalk; thence south, 71 degrees 28 minutes west along south line of Lokey property, a distance of 69.50 feet to the point of beginning of the lot herein described; thence south, 73 degrees 46 minutes west, a distance of 121.50 feet to a point; thence north, 6 degrees 05 minutes west, a distance of 210.0 feet to a point; thence north, 87 degrees 44 minutes east, a distance of 116.31 feet; thence south, 7 degrees 14 minutes east, a distance of 180.62 feet to the point of beginning; being situated in Columbiana, Shelby County, Alabama.

I surveyed said lot during the month of February, 1956. The south line of said lot is the north line of East College Street. The east line of said lot is a portion of the west line of Mrs. Willie Lokey's lot and/the boundary thereof is marked by an old hedge row and the remainder by the vestige of an old established fence. The north line of the lot is the south line of land belonging to the estate of J. H. Crawford and it is marked by the vestige of an old established fence. The west line of said lot is the east line of lot owned by George M. Horn and Ross Bob Mullins and by Simon Finley and others and said west line so far as it runs along the Finley lot is marked by a fence located either on the line or a few inches west of the above described lot. Affiant further says that he has been in the town of Columbiana for the past 15 years and knows that said lines along East College Street, along Mrs. Willie Lokey's lot, along the land of J. H. Crawford's estate and the line along the Simon Finley lot have been the same throughout all the years affiant has known them. Affiant further says he understands that the west line of said lot described above lying north of said Finley lot has been well established and uncontested since the year 1945 when Nathan T. My name is Karl C. Harrison. I am 48 years of age and was born in Columbiana, Alabama, and have lived here most of my life and have all along been well acquainted with the lot described in the foregoing affidavit of James L. Ray, Jr. and the persons in possession of said lot. Except for that portion which Nathan T. Atchison purchased from Harry Gordon in 1945, my father rented the above described land and moved on it with his family, which included affiant, in the year 1916 and affiant says he and his family continued to live on said lot until about the year 1926, and affiant has all along, since that time been familiar with said lot and the lines thereof. Affiant further says that he knows that the lines of said lot, as the same existed when James L. Ray, Jr. Surveyed it in February 1956, have been unchanged throughout all the years affiant has known it and all of said lot was enclosed by a fence during the years affiant lived on said land, except for the portion fronting the street and it has a brick wall across the greater portion of it. Affiant says he recalls that Nathan T. Atchison did buy some additional land from Harry Gordon in 1945 and moved the fence so as to include all of the lot described in said affidavit by James L.
