DECREE OF DIVORCE

THIS CAUSE coming on regularly to be heard this 27th day of March, 1956, the plaintiff appearing in person and by and through his attorneys, Virginia Hash and Edgar Hash, and the defendant appearing in person and by and through her attorneys, Gorodezky, Mitchell & Stuart, Sheldon Mitchell being present, and both sides announcing ready, thereupon the Court proceeded to hear said cause.

Plaintiff was sworn and testified as to the allegations in his said complaint, and was cross-examined and excused, and corroborating witnesses were sworn and testified for and on behalf of plaintiff, and plaintiff rested.

Defendant was sworn and testified on her own behalf and was excused, and the cause was submitted to the Court for finds and judgment.

Upon duly considering the premises and the law applicable thereto, the Court finds that the allegations of plaintiff's complaint have been sustained. The Court further finds that the child set out in defendant's answer, to wit: Jacklyn Delores Carter, is not the child of the plaintiff herein, and further finds that the two younger children, to wit; Jack Douglas Carter, Jr. and James David Carter are the children of plaintiff and defendant above.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

1. That plaintiff be, and he is hereby awarded an absolute divorce from the defendant, and the bonds of matrimony heretofore existing between plaintiff and defendant are hereby dissolved and set at naught, and plaintiff and defendant are hereby restored to the status of single persons;

2. That the custody of the two minor children of the parties, to wit: Jack Douglas, Jr. and James David, be and the same is hereby awarded to the defendant, with reasonable visitorial rights to plaintiff.

3. That the plaintiff shall pay to the defendant, for the support and maintenance of his two children, to wit: Jack Douglas Carter, Jr. and James David Carter, the sum of \$100.00 per month
