Before me, W. W. Rabren, a notary public for the State of Alabama at large, personally appeared Vergil Jarvis, , who is known to me and after first being duly sworn to speak the truth deposes and saith as follows: My name is Vergil Jarvis and I am 40 years of age. I have resided all my lifetime near the hereinafter described lands and live across the road from them at this time at Route 1, Marvel, Shelby County, Alabama; I have been acquainted with the occupants of the following described lands since I was old enough to be aware of who lived near us:

Lot in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 1, Township 22, Range 4 West described as beginning where the South right of way line of the Dogwood road intersects the West line of said SW $\frac{1}{4}$ of NW $\frac{1}{4}$ and run South 420 feet; run thence East 210 feet; run thence North 420 feet, to the South right of way line of said Dogwood Highway; run thence West 210 feet along said right of way line to the point of beginning, formerly known as the Jennie and Joe Kish lot.

Also a lot in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 1, Township 22, Range 4 West, described as beginning at the Southwest corner of the property formerly known as the Joe Kish place and run South to the Northwest corner of the land formerly belonging to J. M. Kitchens; thence East 70 yards; thence North to the Southeast corner of the Joe Kish property; thence West 70 yards to the point of beginning, containing two acres, more or less. Situated in Shelby County, Alabama.

I was born and raised on the property which my mother and daddy bought from my father's daddy in 1906 as shown in deed dated September 21, 1906 and recorded in deed book 44, page 172 of the office of the Judge of Probate, Shelby County, Alabama. I know that in the years 1929 and 1930 that my uncle (my father's brother) Jno. L. Jarvis was not in possession of any part of the above described lands and that the only lands he was ever in possession of near the above described lands was located on the East side of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 1, Tp. 22, Range 4 West. My Mother and Father, myself and my sisters and brothers were living on the above described lands in the years 1929 and 1930. I have never known of Jno. L. Jarvis claiming any interest in any part of the above described lands. I have never known of anyone questioning the title of the record owners of the above described property.
