I have lived for the past fifty years on lands adjacent to the following described lands:

Lot in the SW¼ of NW¼ of Section 1. Township 22, Range 4 West, described as beginning where the South right of way line of the Dogwood road intersects the West line of said SW¼ of NW¼ and run South 420 feet; run thence East 210 feet; run thence North 420 feet, to the South right of way line of said Dogwood Highway; run thence West 210 feet along said right of way line to the point of beginning, formerly known as the Jennie & Joe Kish Lot.

Also a lot in the SW% of NW% of Section 1. Township 22. Range 4 West, described as beginning at the Southwest corner of the property formerly known as the Joe Kish place and run South to the Northwest corner of the land formerly belonging to J. M.
