Comes before me, W. W. Rabren, a Notary Public for the State of Alabama at large, H. W. Goodwin, who being by me first duly sworn to speak the truth deposes and says the following:

My name is H. W. Goodwin and I am known as Henry Goodwin. I am 71 years of age and was born and raised near Sterrett, Shelby County, Alabama, and have lived in and near Sterrett all my life time. I am well acquainted with the S½ of NE% of NE% Section 2 Township 19, Range 1 East, Huntsville Meridian, Shelby County, Alabama. I remember that as far back as the first part of the year 1883 John W. Spradley was in possession of the above described lands which he had purchased according tokthe record in 1878 from Robert J. Byers and wife, Ann Eliza Byers. I was born and raised on lands adjacent to the above described lands as my Father owned lands adjacent to the above described lands. I know from my own personal knowledge that from the first part of the year 1883 until the death of John W. Spradley about the year 1892, that the possession of John W. Spradley had been open, Notorious, peaceful, quiet, direct, adverse, hostile, and under color of title and claim of ownership, and I further know from my own personal knowledge that during that period of time, no one else was in possession of any part of the above described lands claiming adverse to the said John W. Spradley.

After the death of John W. Spradley about the year 1892, which I witnessed as a boy of about 8 or 9 years of age, Mr. Asa Goodwin, who was the Son-in-Law of John W. Spradley, went into possession of the above described lands and Asa Goodwin and wife, Liza Spradley Goodwin, held the possession of the above described lands as the heirs at law of John W. Spradley and their possession was open, Notorious, peaceful, quiet, direct, adverse, hostile, and under color of title and ownership, until the year about 1896 when Asa Goodwin and wife sold the above described land to Jefferson J. Falkner. I remember this for the reason that about the year 1895 my Mother and Father passed away together and three of my brothers, my sister, and I went to live with Jefferson J. F. Ikner, and he raised us children. I know that from the year that Jefferson J. Falkner bought the above described lands from Asa Goodwin until the year 1910 when he sold the above described lands to Paul Hoffman by Deed which is recorded in Deed Book 45 page 84 of the Office of Judge of Probate, Shelby County, Alabama, that the possession of the said Jefferson J. Falkner, Asa Goodwin and John W. Spradley as far back as the first part of the year 1888 which I referred to above has been open, notorious, peaceful, quiet, direct, adverse, hostile, and under color of title and claim of ownership.

I know that no one else during the years from 1888 to the year that Mr. Jefferson J. Falkner sold to Paul Hoffman in 1910 that no one else was in possession of any part of the above described lands during that period claiming adverse to the said Jefferson J. Falkner. As Goodwin and John W. Spradley, nor have I ever known of anyone claiming any right, title or interest in or to the above described lands adverse to the said owners during that period.
