right, title, interest and claim in or to the following described real estate, to wit:
That lot of land described in deed dated December 4, 1903, from T. A. Bearden and
wife, Lizzie Bearden, to T. A. Bearden, J. L. McGaughy and J. T. McGaughy, as
trustees for Salem School Community which is recorded in Deed Book 50 page 61 in
the Office of Judge of Probate, and was described in said deed as follows: One
lot of land lying on the opposite side of the Montevallo and Elyton road from Salem
grave yard in the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 9 Township 22 South Range 3 West, the said
lot being described as follows: Beginning on the East side of said road at a large
post oak tree standing in front of the present school house on said lot, running
thence Northerly along the Eastern side of said road a distance of 66 feet from the
center of said tree; thence Eastwardly perpendicular to said road a distance of 90
feet; thence Southwardly parallel with said road a distance of 132 feet, thence
Westerly 90 feet to the Eastern side of said road and thence Northerly along the
