KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Dollars to the Town of Columbiana, Alabama, a municipal corporation, in hand paid by J. L. Brand, the receipt whereof is hereby acknowledged, it does remise, release, quit claim and convey to the said J. L. Brand all its right, title, interest and claim in or to the following described real estate, to-wit:
