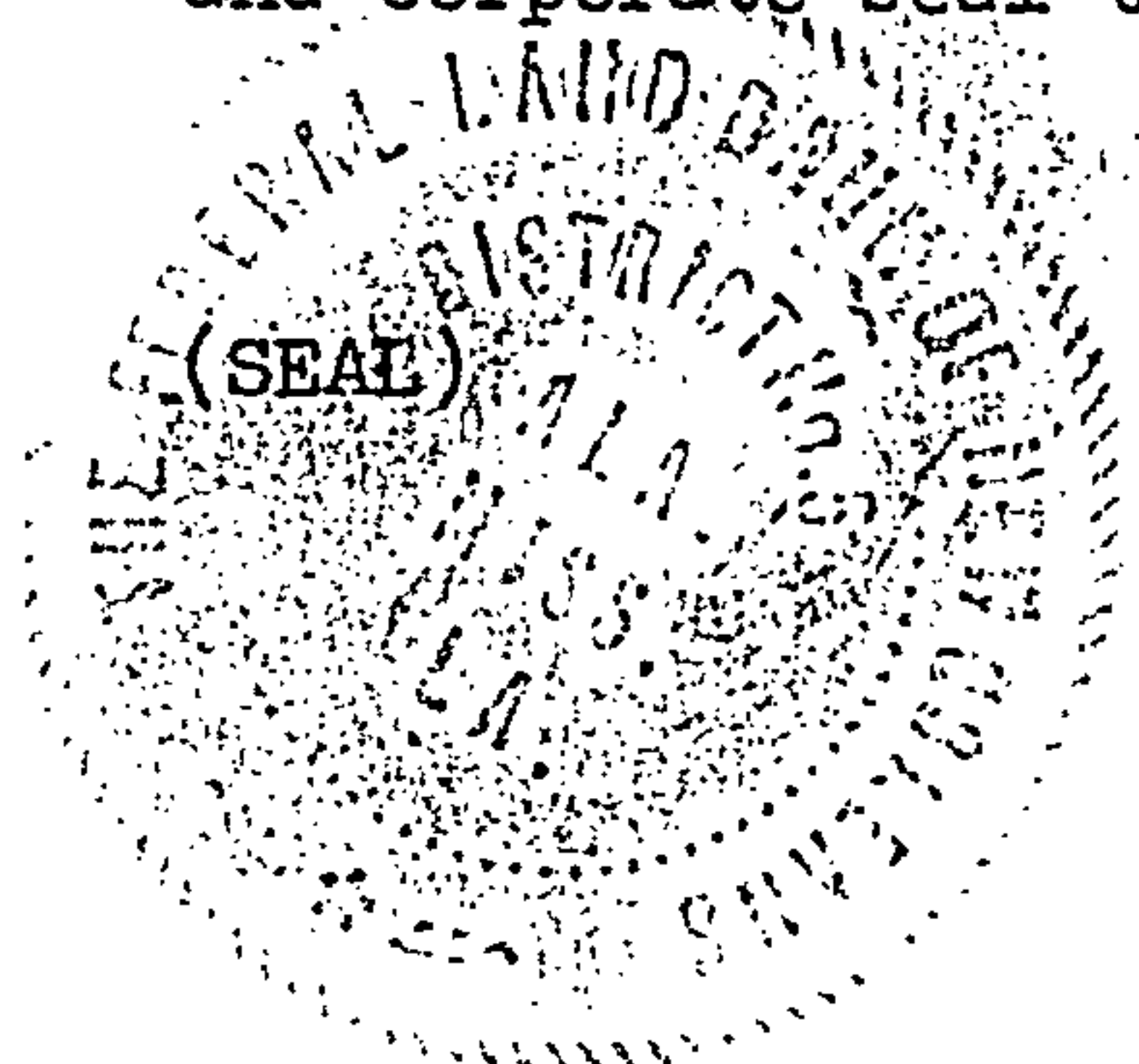

BEGIN AT THE SE CORNER OF SW 1/4 OF NE 1/4 OF SECTION 9, TOWNSHIP 24 NORTH, RANGE 12 EAST, THENCE WESTERLY AND ALONG THE SOUTHERLY LINE OF SAID QUARTER-QUARTER SECTION 741.65 FEET TO THE CENTER LINE OF THE OLD SELMA ROAD; THENCE TO THE RIGHT IN A NORTHEASTERLY DIRECTION AND ALONG THE CENTER LINE OF SAID ROAD 500 FEET, MORE OR LESS; THENCE 107°49' TO THE LEFT IN A WESTERLY DIRECTION 396.6 FEET TO THE EXTREME SOUTHWESTERLY CORNER OF THE WILMONT SUBDIVISION; THENCE 61°17' TO THE RIGHT IN A NORTHWESTERLY DIRECTION AND ALONG THE NORTHEASTERLY LINE OF SAID WILMONT SUBDIVISION 1150.9 FEET TO THE NORTHWESTERLY LINE OF BEARDON STREET IN SAID SUBDIVISION; THENCE TO THE RIGHT NORTHEASTERLY AND ALONG THE EXTENSION OF SAID NORTHEASTERLY LINE OF BEARDON STREET 550 FEET TO THE NORTHEASTERLY LINE OF A STREET; THENCE TO THE RIGHT SOUTHEASTERLY AND ALONG SAID NORTHEASTERLY LINE OF SAID STREET 295 FEET, MORE OR LESS, TO THE SOUTHWESTERLY CORNER OF THE MARK JONES PROPERTY; THENCE TO THE LEFT EASTERLY AND ALONG THE SOUTHERLY LINE OF SAID MARK JONES PROPERTY 530 FEET, MORE OR LESS, TO THE AFOREMENTIONED CENTER LINE OF SAID OLD SELMA ROAD; THENCE TO THE LEFT NORTHEASTERLY AND ALONG SAID CENTER LINE OF SAID OLD SELMA ROAD TO ITS INTERSECTION WITH THE NOW ABANDONED OLD COUNTY ROAD; THENCE TO THE RIGHT SOUTHEASTERLY AND ALONG SAID ABANDONED-OLD COUNTY ROAD TO THE EAST LINE OF THE ABOVE MENTIONED QUARTER-QUARTER SECTION; THENCE TO THE RIGHT SOUTHERLY AND ALONG SAID EASTERLY LINE OF SAID QUARTER-QUARTER SECTION 1,050 FEET, MORE OR LESS, TO THE SOUTHEAST CORNER THEREOF, THE POINT OF BEGINNING, CONTAINING 29 ACRES MORE OR LESS.
