and egress thereto and therefrom, in under, over, and along the following described

property: A strip of land 20 feet wide lying 10 feet on each side of the following described center line.

Commence at the Northeast corner of Section 7, Township 22 South, Range 2 West, run Westward along the North line of said section a distance of 2306.5 feet to the point of beginning; thence at an angle of 158 degrees 40 minutes to the left, run in a Southeasterly direction a distance of 846.7 feet to a point; thence at an angle to the right of 16 degrees 30 minutes run a distance of 747.5 feet to a point; thence at an angle to the left of 11 degrees 37 minutes run a distance of 1091.7 feet, more or less, to a point on the East line of Section 7, said point being 1261.5, more or less, from the Northeast corner of Section 7.
