in hand paid by J. H. Kirkland and wife, Wilma Kirkland,

the receipt whereof is acknowledged we the said C. W. Morris and wife, Bertha S. Morris ;
and H. P. Lipscomb, Jr., a single man,

do grant, bargain, sell and convey unto the said J. H. Kirkland and wife, Wilma Kirkland,

as joint tenants, with right of survivorship, the following described real estate, situated in

Shelby County, Alabama, to-wit:



Beginning at an iron stake at the SW corner of the SW 1/4 of the SE 1/4 of Sec. 28, Township 20, Range 4 West, thence north along the quarter section line 968 feet to an iron stake on the south side of right of way of the paved highway running from Genery's Gap; thence north 39° 33' east 385 feet along said right of way to an iron stake being the NW corner of the lot; thence south 49°30' east 1089 feet to an iron stake, being the SW corner of the lot; thence north 38°48' east 200 feet to an iron stake, being the SE corner; thence north 49°30' west 1089 feet to an iron stake, being the NE corner, thence along the right of way of the paved highway south 38°48' west 200 feet to point of beginning, including five acres more or less.

TO HAVE AND TO HOLD Unto the said J. H. Kirkland and wife, Wilma Kirkland,

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances.
