

RELEASE FROM LIEN OF MORTGAGECORPORATE



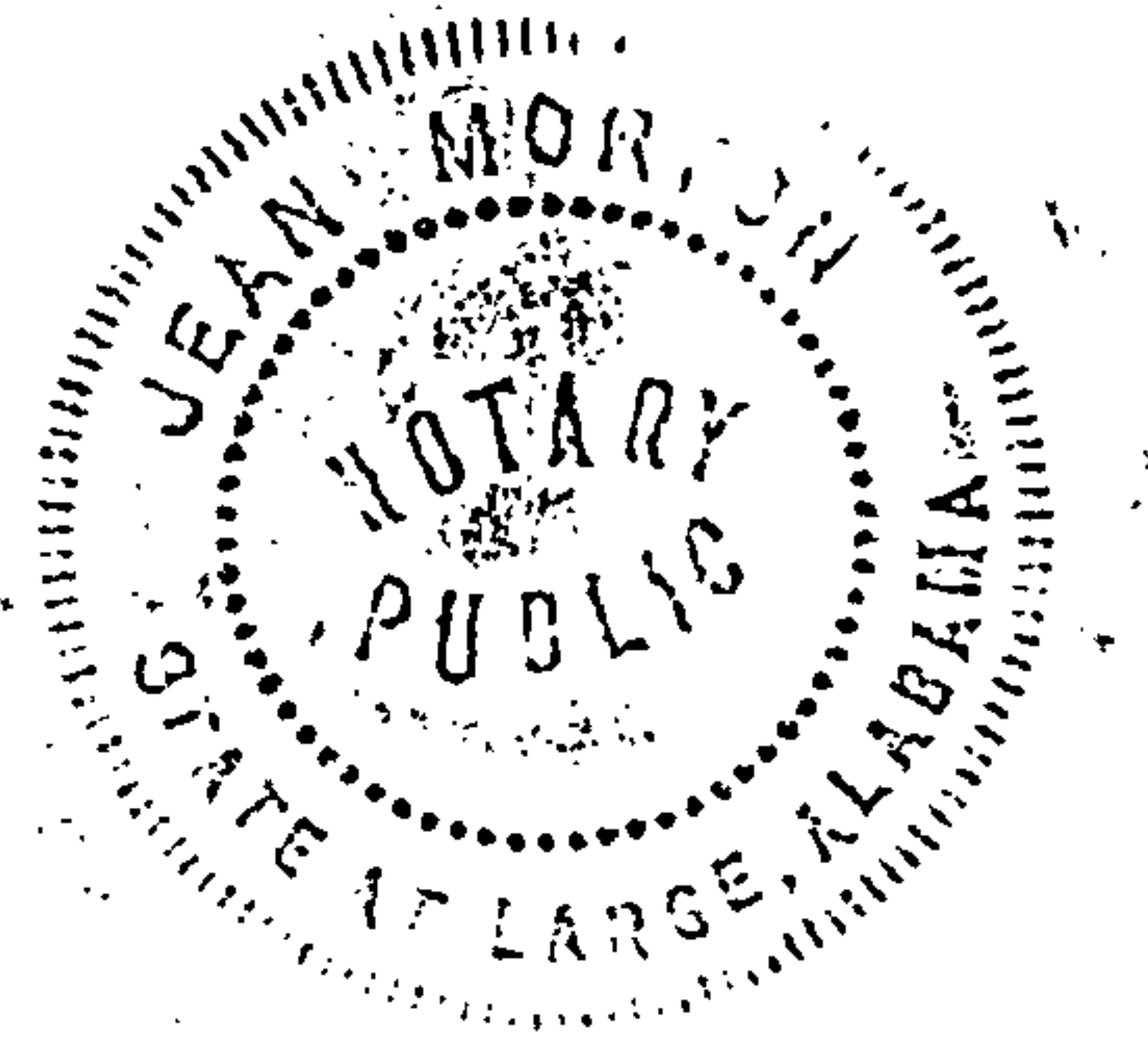
