I am acquainted with the following land situated in Shelby County, Alabama, namely:

The SE $\frac{1}{4}$ of NW $\frac{1}{4}$, and 20 acres onthe North side of the NE $\frac{1}{4}$ of SW $\frac{1}{4}$, all in Section 14, Township 21, Range 1 West.

My wife, Amelia M. Embry obtained a deed to said property from A. Page Sloss and others, dated March 22, 1927, and recorded in the Probate Office of Shelby County, Alabama, in Deed Book 81, page 436. She went into possession of said property immediately upon the execution of the aforementioned deed. She went into possession of the entire SE¹/₄ of NW¹/₄ and the 20 acres off the North side of NE¹/₄ of SW¹/₄ as soon as she received the deed aforesaid and has remained in the actual, open, notorious, continuous, exclusive, adverse, hostile possession of said property down to the present time. She sold the timber off the land twice and the timber was cut from the entire SE¹/₄ of NW¹/₄ as well as the 20 acre tract of land. As her agent I have looked after the property and kept timber cutters off it and have seen after it regulafly down through the years to the present time.

As to 8 acres off the North side of the $S\frac{1}{2}$ of $NE^{\frac{1}{4}}$ of $SW^{\frac{1}{4}}$, Section 14, Township 21, Range 1 West, I procured a deed to it from Jack T. Atchison and wife, on April 13, 1950, which deed is recorded in the Probate Office of Shelby County, Alabama, in Deed Book 142, page 48. This 8 acre tract was formerly owned by J. L. Peters, but he did not part with title to it and died and left two children only, namely, Mary Peters and Ella Peters, who were his sale heirs at law and next of kin, and they deeded the property to Jack T. Atchison on March 11, 1950, which deed is recorded in the Probate Office of Shelby County, Alabama, in Deed Book 142, page 47. I have been in possession of this 8 acre tract of land continuously since I obtained the deed aforesaid and have exercised acts of ownership over it down to the prement time by keeping people off it and seeing after it along with the property owned by my wife.
