Before me, the undersigned authority, in and for said County, in said State, personally appeared W.F. Robertson, who, being first duly sworn, deposes and says that his Post Office address is Wilsonville, Shelby County, Alabama, and that he resides near Wilsonville, Alabama, and has so resided all of his life; that for more than forty-five years, last past, he has been acquainted with the location, use, possession, parties in possession and parties claiming to own the following described lands situated in Shelby County, Alabama, to-wit:

The Southwest Quarter of the Northeast  
Quarter of Section 32, Township 20, Range  
2 East, in Shelby County, Alabama.

Affiant further says that when he can first remember that there was a farm house on said lands and that Hosey Kidd, a colored man, resided in said house and cultivated the said above described lands in farm crops, and the community report was that the said property belonged to the said Hosey Kidd, and that the said Hosey Kidd inherited said lands from some of his relatives, his Mother, Effie Kidd, that the said Hosey Kidd has been dead for a number of years, and affiant does not know whether or not he has any next of kin surviving him.

Affiant further says that said lands sold to the State of Alabama for the non-payment of taxes a number of years ago, and that he remembers the occasion when the said lands were purchased from the said State of Alabama by Paul O. Luck, and his associate, R. Brewer; and that the said Paul O. Luck, for himself and his associate, as aforesaid, went into the immediate possession of said lands and rented the farm house and the lands to one, Harrison Jordan, who resided therein and thereon for several years as a tenant of the said Paul O. Luck and his associate, R. Brewer.

Affiant further says that he knows of his own personal knowledge that Paul O.Luck, and his associate, R.Brewer, have been in the continuous, open, notorious, peaceable possession of said lands since the date of the purchase of said lands from the State of Alabama, and that said possession has been free from any claim, demand, or question on the part of any one.

Affiant further says that the said Paul O.Luck and his associate have continuously used said lands; first, in having the same cultivated in crops; have cut and hauled therefrom timber, have posted said lands, marked the boundaries thereof, and said Paul O.Luck, since he purchased the interest of the said associate, R.Brewer, has used said lands in the preparation for building a residence thereon, has graded roads there through and has had constructed power lines to said proposed improvements on said lands.

Affiant further says that he has never heard the title of the said Paul O.Luck, and those through whom he holds title, as aforesaid, to be questioned by anyone.
