Potts, all its right, title and interest in and to the following land lying and being in the County of Shelby, State of Alabama, described as follows, to-wit:-

Commencing at the center point of Section 3, Township 24 North, Range 12 East and run thence with the land line North 1 deg. 35 min. West 838.6 feet to a point 30 feet south of the center line of the Calera-Centerville paved highway; run thence North 85 deg. 50 min. West 322 feet along with and parallel to said highway; run thence South 4 deg. 11 min. East 120 feet; run thence South 85 deg. 49 min. West 245 feet to the point of beginning; run thence South 85 deg. 49 min. West 172 feet; run thence North 17 deg. 58 min. 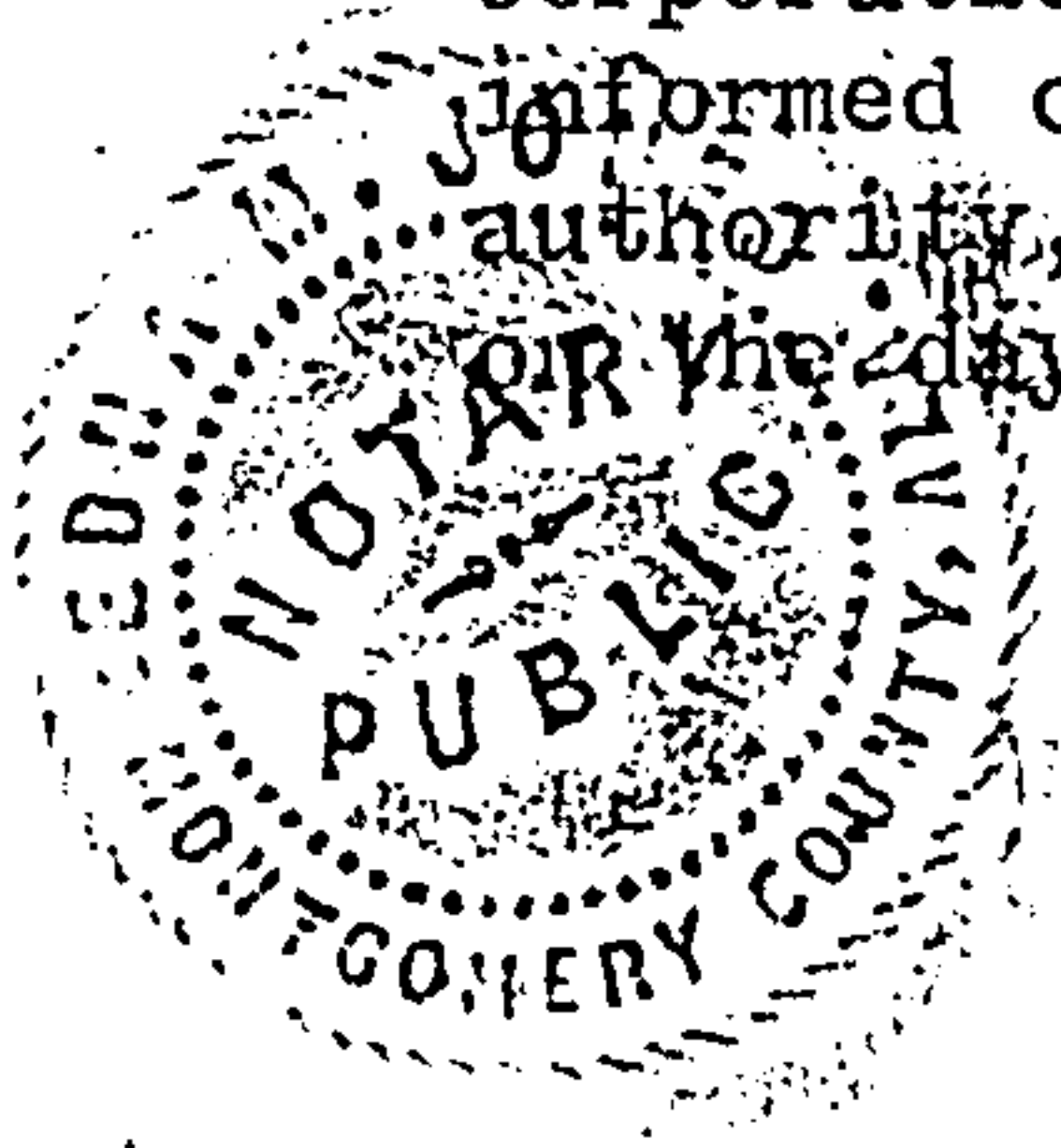

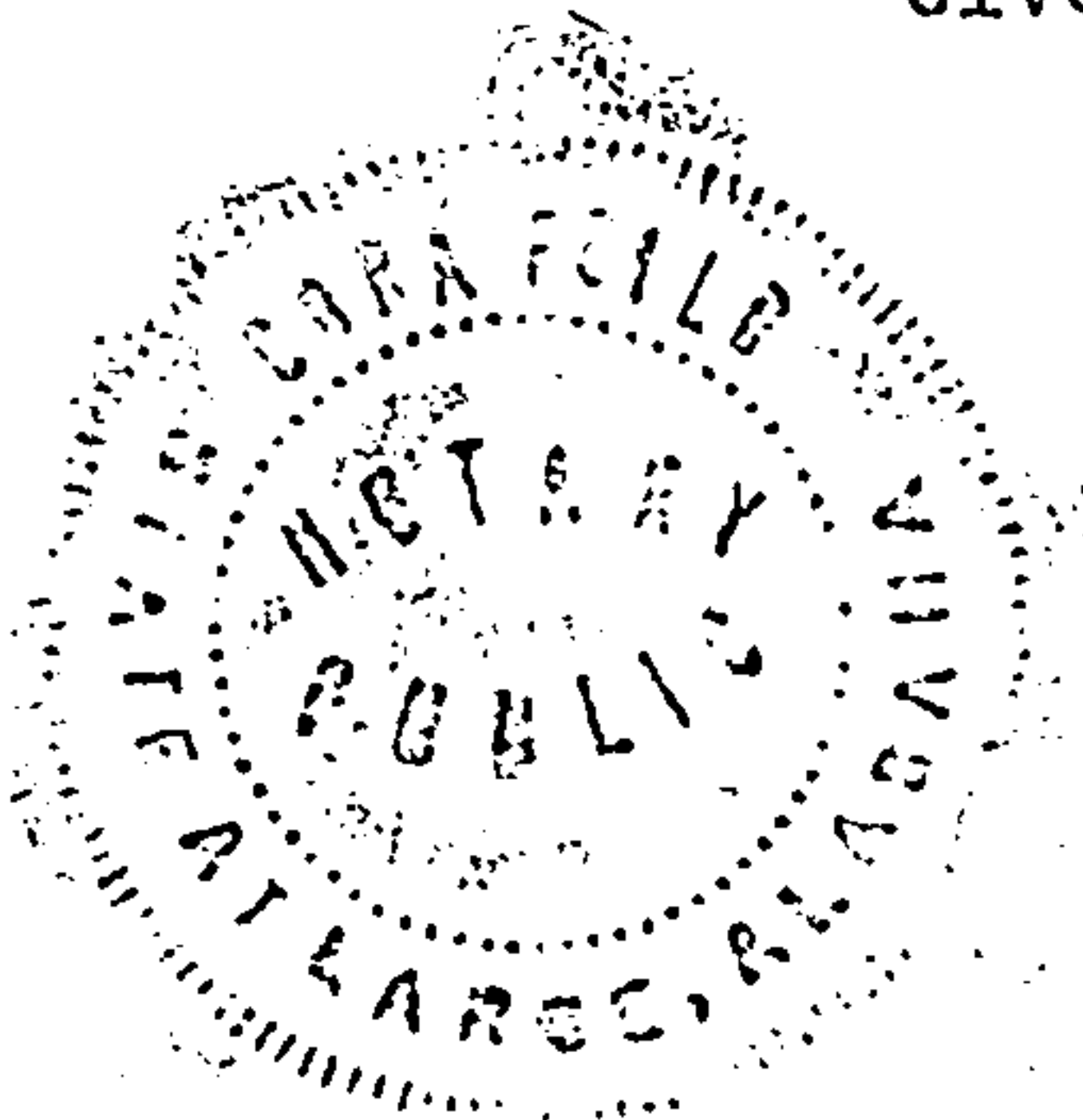
