Our names are Margaret Brewer Barefield and Beatrice Brewer Bell. We live, respectively, at 221 North 65th Place, Birmingham, Alabama, and 6717 South Second Avenue, Birmingham, Alabama. We are two of the children born to Washington Brewer and Mary Jane Brewer.

In March of 1948 all of the children or the heirs of Washington Brewer and Mary Jane Brewer executed a deed to certain property in Shelby County, Alabama, to Mr. Frank G. Brewer, our brother. At that time the children and heirs of Washington Brewer and his wife, Mary Jane Brewer, were as follows: William H. Brewer and wife, Myrtle Brewer; Beatrice Brewer Bell and husband, Floyd M. Bell; Mrs. Hattie Brewer Littlejohn, a widow; Mrs. Margaret Brewer Barefield, a widow; Mrs. Katie Brewer Scrogins, unmarried. Monroe A. Brewer died in July of 1940 and his widow was also dead at the time of the execution of the deed. However, they left surviving them Mrs. Ilga B. Graham and husband, John R. Graham; Miss Beatrice Brewer, single; Miss Jeanette Brewer, single; Monroe F. Brewer and wife, Grace Brewer; and Donald M. Brewer and wife, Vera Brewer. Mrs. Allie Brewer Breed died in May, 1942, leaving surviving her a husband, Mr. W. H. Breed, and the following children: Harry M. Breed, single; Herbert R. Breed and wife, Myrtle Breed; Alva M. Breed and wife, Annie Mae Breed; Mrs. Nell B. Prescott and husband, W. H. Prescott; Mrs. Mary B. Woodruff and husband, Croyley Woodruff; Mrs. Claire B. Cooper and husband, Leon Cooper. T. Lee Brewer died in October, 1933, leaving surviving him a wife, Mrs. Eunice Brewer, and the following children: W. T. Brewer and wife, Jane Brewer; Mrs. Mary Brewer Bradley and husband, Albert Bradley; Mr. Ben Brewer and wife, Galeta Brewer; Mrs. Marjorie Brewer Garner, a widow. There was one other child of Washington and Mary Jane Brewer, Mallie J. Brewer, however, she died at the age of twelve.

The above named persons were the only children and heirs of Washington and Mary Jane Brewer as of March, 1948.
